COURT OPINION

Commonwealth of Pennsylvania

v.

Hector V. Rivera

No. 2-2013-Criminal

Attorney for Defendant: Scott Bennett, Esquire

Summary of the Case

Before the Court was Defendant's appeal of the Court's Order denying his Motion for Sentence Modification. Defendant originally pled guilty to Receiving Stolen Property and was sentenced to twelve (12) months' probation, to pay restitution in the amount of \$55.00, refrain from the use of controlled substances, submit to random drug testing and pay \$500 for the cost of the public defender. Defendant thereafter filed a Motion for Modification requesting that the cost of the public defender be struck as a condition of probation, arguing that the Court lacks statutory authority to impose such an order and also that there is no evidence of record supporting the basis for the \$500 cost.

The Court opined that the United States Supreme Court has held that there is no constitutional prohibition to a state court conditioning probation on an offender's reimbursement of the costs of the public defender, if the offender is financially able to make such reimbursement. Fuller v. Oregon, 417 U.S. 40 (1974). The Court then identified that in Pennsylvania, sentencing courts must do two things when imposing such orders: 1) specifically make reimbursement of costs a condition of probation at the time of sentencing; and 2) take into consideration a defendant's ability to pay the cost and te financial burden that will be placed on a defendant. Commonwealth v. Pride, 380 A.2d 1267 (Pa.Super. 1977); Commonwealth v. Opara, 362 A.2d 305 (Pa.Super. 1976).

In <u>Pride</u>, the trial court's sentencing order did not condition the defendant's probation on payment by the defendant of the cost of his representation. <u>Id</u>. at 1270. The Superior Court reasoned that it was bound by the sentence of the trial court and could not "redefine the repayment order as a probation condition or fine to transform a statutorily unauthorized repayment into a permissible order." <u>Id</u>. The Court indicated that the lower court could have properly imposed the disputed cost had it done so clearly as a condition of the defendant's probation at the time of sentencing. <u>Id</u>.

In the case at bar, payment of the cost of representation by the public defender was made an explicit condition of Defendant's probation and served the rehabilitative measures of the Court. The Court noted that probation is a constructive alternative to imprisonment and the conditions of a defendant's probation are tailored to the individual in a manner that best serves the community and also a defendant's reintegration into society as a law-abiding citizen. As a result, the Court initially determined the fee was a permissible condition of probation.

Next, the Court considered the financial burden of the cost to Defendant. The Court reviewed the details of Defendant's Pre-Sentence Investigation to determine that Defendant had the capacity to work and earn money to pay his fines, costs and restitution and was therefore able to pay the cost. Finally, the Court opined that Defendant's failure to pay would result in another hearing pursuant to Pa.R.Cr.P. 708 at which time Defendant would be provided an opportunity to be heard regarding any allegation of indigency and reasons for the failure to pay.

Finally, the Court noted that Defendant received pecuniary gain from his crime and that Defendant was a repeat offender. It was the Court's opinion that restitution of \$55.00 alone would be insufficient to deter Defendant in the future, and that bearing the cost of the public defender provides a more appropriate deterrent while also serving the rehabilitative measures of the Court. Inasmuch as courts are provided with flexibility to determine "all the direct and indirect damages caused by a defendant and then order restitution so that the defendant will understand the egregiousness of his conduct, be deterred from repeating this conducts, and be encouraged to live in a responsible way." Com v. Harner, 617 A.2d 702, 706 (Pa. 1982).

The Court therefore determined that there was no issue which merited a modification of Defendant's sentence, and respectfully requested the Superior Court also find no merit in Defendant's appeal.



CRIMINAL CASES

The following cases were addressed by the Honorable Raymond L. Hamill, President Judge, Wayne County on August 29, 2013

ANGELA T. BOSSICK, age 24 of Waymart, PA was sentenced, in two separate cases, to the Wayne County Correctional Facility for a period of not less than 72 hours and 1 month nor more than 12 months for one count of DUI-Cont Sub-Impaired Ability/1st Offense, an ungraded Misdemeanor, one count of Possession of Drug Paraphernalia, an ungraded Misdemeanor and one count of Possession of Controlled Substance, also an ungraded Misdemeanor. She was also ordered to pay all Court costs, pay a fine in the amount of \$1,200.00, undergo a drug and alcohol evaluation and comply with all recommendations for treatment, attend and complete an alcohol highway safety program, obtain full time employment and perform 50 hours of community service. The first incident occurred on March 8, 2013, in Honesdale Borough when Honesdale Borough Police observed Bossick swerving in her lane of travel. At that time Bossick was under the influence of several controlled substances. The second incident occurred on June 19, 2013, in Texas Township when Bossick was in possession of a controlled substance for which she did not have a valid prescription.

CORY A. HATTLER, age 26 of Honesdale, PA was sentenced to the Wayne County Correctional Facility for a period of not less than 1 month nor more than 23 ø months for one count of Theft By Unlawful Taking or Disposition, graded as a Misdemeanor of the 1st Degree. He was also ordered to pay all court costs, pay restitution in the amount of \$820.00, perform 50 hours of community service, undergo a mental health evaluation and comply with all recommendations for treatment, and obtain full time employment. The incident occurred on December 30, 2012, in Hawley Borough when Hattler stole money belonging to another.

VICTORIA M. LINSALATO, age 24 of Honesdale, PA was placed on probation for a period of 6 months for one count of Criminal Conspiracy-Possession of Controlled Substance, and ungraded Misdemeanor. She was also ordered to pay all Court costs, pay a fine in the amount of \$300.00 and undergo a drug and alcohol evaluation and comply with all recommendations for treatment. The incident occurred on February 25, 2013, in Honesdale Borough when Linsalato conspired with another to possess Marijuana.

JONATHAN P. SAWICKI, age 25 of Lake Ariel, PA was sentenced to the Wayne County Correctional Facility for a period of not less than 3 months nor more than 6 months for one count of DUI, an ungraded Misdemeanor and one count of Driving While Operating Privilege Suspended/Revoked, graded as a Summary offense. He was also ordered to pay all Court costs, pay a fine in the amount of \$700.00, undergo a drug and alcohol evaluation and comply with all recommendations for treatment and attend and complete an alcohol highway safety program. The incident occurred on February 27,

2013, in South Canaan Township when Pennsylvania State Police were called to investigate the report of a one vehicle crash. His BAC was .103%.

NICHOLAS J. STRASSER, age 50 of Hawley, PA was sentenced to the Wayne County Correctional Facility for a period of not less than 3 days nor more than 6 months for one count of DUI-Highest Rate, an ungraded Misdemeanor. He was also ordered to pay all Court costs, pay a fine in the amount of \$1,000.00, undergo a drug and alcohol evaluation and comply with all recommendations for treatment, attend and complete an alcohol highway safety program, obtain full time employment and perform 50 hours of community service. The incident occurred on December 21, 2012, in Texas Township when Hawley Borough Police were called to investigate the report of an intoxicated driver. His BAC was .320%.

WILLIAM A. SWENDSEN, age 31 of Honesdale, PA was sentenced to a State Correctional Facility for a period of not less then 20 months nor more than 60 months for one count of DUI or Controlled Substance, graded as a Misdemeanor of the 2nd Degree, one count of Receiving Stolen Property, graded as a Misdemeanor of the 2nd Degree and one count of Possession of Controlled Substance, an ungraded Misdemeanor. He was also ordered to pay all Court costs. The incidents occurred on September 30, 2013, in Honesdale Borough when Swendsen received a cell phone knowing that it had been stolen. At that time Swendsen was under the influence of Oxycodone and in possession of Heroin.

JOSHUA D. TIGHE, age 18 of Lake Ariel, PA was sentenced to the Wayne County Correctional Facility for a period of not less than 31 days nor more than 12 months for one count of Theft By Unlawful Taking or Disposition, graded as a Misdemeanor of the 1st Degree. He was also ordered to pay all Court costs, pay restitution in the amount of \$460.00, undergo a drug and alcohol evaluation and comply with all recommendations for treatment, and obtain full time employment. The incident occurred between May 16, 2013, and May 21, 2013, in Salem Township when Tighe stole checks belonging to another.

BRETT MICHAEL WISE, age 24 of Honesdale, PA sentenced to the Wayne County Correctional Facility for a period of not less than 3 months nor more than 6 months for one count of DUI-Highest Rate, an ungraded Misdemeanor. He was also ordered to pay all Court costs, pay a fine in the amount of \$1,025.00, undergo a drug and alcohol evaluation and comply with all recommendations for treatment, attend and complete an alcohol highway safety program and obtain full time employment. The incident occurred on April 28, 2013, in Honesdale Borough when Honesdale Borough Police observed Wise fail to stop at a properly posted intersection. His BAC was .223%.

STEPHANIE BOSSICK, age 22 of Waymart, PA was placed on the Accelerated Rehabilitative Disposition Program for a period of 6 months related to DUI. She was also ordered to pay all Court costs, perform 40 hours of community service, and attend and complete an alcohol highway safety program. The incident occurred on March 22,

2013, in Canaan Township when Pennsylvania State Police were called to investigate the report of a one vehicle crash. Her BAC was .078%.

ANGELA DEGRAW, age 26 of Matamoras, PA pled guilty to one count of Theft BY Failure to Make Required Disp. Of Funds, graded as a Misdemeanor of the 2nd Degree. The incident occurred on December 28, 2010, in Honesdale Borough. She is scheduled to be sentenced on October 17, 2013.

JOSHUA C. LEONARD, age 19 of Waymart, PA pled guilty to one count of Theft By Unlawful Taking or Disposition, graded as a Misdemeanor of the 1st Degree and one count of Receiving Stolen Property, graded as a Misdemeanor of the 2nd Degree. The incidents occurred between May 2012, and July 2012, in South Canaan Township when Leonard stole farm equipment. He is scheduled to be sentenced on October 17, 2013.

WAYNE S. SMITH, age 59 of Roscoe, NY pled guilty to one count of DUI-Highest Rate, graded as a Misdemeanor of the 1st Degree. The incident occurred on May 31, 2012, in Texas Township when Pennsylvania State Police were called to investigate the report of an erratic driver. His BAC was .323%. He is scheduled to be sentenced on October 17, 2013.

MARY STEELMAN, age 55 of Equinunk, PA pled guilty to one count of DUI, an ungraded Misdemeanor. The incident occurred on January 28, 2011, in Honesdale Borough. Her BAC was .138%. She is scheduled to be sentenced on October 17, 2013.

RUSSELL A. WEAVER, age 32 of Moscow, PA pled Nolo Contendere to one count of Indecent Assault, graded as a Misdemeanor of the 2nd Degree. The incident occurred between January 2012, and February 2013, in Salem Township when Weaver had indecent contact with a female victim. He is scheduled to be sentenced on October 17, 2013.

AMY L. WHITE, age 23 of Waymart, PA pled guilty to one count of Retail Theft-Take Merchandise, graded as a Misdemeanor of the 1st Degree. The incident occurred between January 12, 2013, and January 29, 2013, in Texas Township when White stole items from a local department store. She is scheduled to be sentenced on October 24, 2013.


