

NEWS FROM THE PENNSYLVANIA BAR ASSOCIATION:

REMINDER: CLE REQUIREMENTS RAISED TO A MINIMUM OF TWO ETHICS CREDITS

PBI is reminding practicing lawyers that the Pennsylvania Supreme Court made two CLE compliance changes for practicing Pennsylvania lawyers last January. Lawyers are now required to have at least two ethics credits per year.

Lawyers are allowed to use up to six distance education credits to satisfy the annual 12-credit requirement. However, distance education credits do not carry over to subsequent years like other credits. For example, an attorney who viewed six hours of CLE from PBI's Online Campus (http://www.legalspan.com/pbi/onlinecle.asp) before his or her deadline in 2014 will not be able to carry two of those credits into the next compliance period.

Both changes became effective with CLE compliance periods beginning on May 1, 2014, meaning that the increased ethics requirement will be enforced for compliance periods ending on April 20, 2015.

WILLS FOR HEROES SEEKS ADDITIONAL COUNTY COORDINATORS, TRAINING FOR LAWYERS TO BE HELD SEPT. 26 AND 27 IN HERSHEY

A special training session is scheduled for Sept. 26 and 27 in Hershey for lawyers who are interested in serving as county coordinators of Wills for Heroes events. A coordinator works with first responder organizations and other program volunteers to set up Wills for Heroes events in his or her county benefitting first responders and military veterans. See the online map (http://www.pabar.org/public/coordmap.asp) showing the Pennsylvania counties that are in need of coordinators.

Wills for Heroes is a free service that provides wills, living wills and financial powers of attorneys to veterans, first responders and their spouses/partners. At the conclusion of one-hour appointments with legal volunteers, veterans, first responders and their spouses/partners receive notarized legal documents. The PBA Young Lawyers Division adopted Wills for Heroes as one of its statewide public service projects in spring 2009. Since that time, more than 5,000 first responders and their spouses/partners have received free wills and estate planning documents.

The county coordinator training will be held at The Hershey Company during the afternoon of Sept. 26 and attendees will participate in a Wills for Heroes Event in Hershey on Sept. 27.
