### CRIMINAL CASES

March 26, 2015 — The following cases were addressed by the Honorable Raymond L. Hamill, President Judge, Wayne County.

**GEORGE MILLER**, age 50 of Newfoundland, PA was sentenced to a State Correctional Facility for a period of not less than 12 months nor more than 84 months for one count of Possession of Child Pornography, graded as a Felony of the 3rd Degree. He was also ordered to pay all Court costs and submit to the drawing of a DNA sample. The incident occurred between November 25, 2011 and January 21, 2013 in Dreher Township, PA.

**HEATHER STUDENROTH**, age 33 of Kingston, PA was sentenced to probation for a period of not less than 60 months for one count of Theft by Unlawful Taking or Disposition, graded as a Misdemeanor of the 1st Degree. She was also ordered to pay all Court costs and pay restitution in the amount of \$87,000.00. The incident occurred between May 1, 2008 and May 12, 2013 in Salem Township, PA.

RONALD CHAMBERLAIN, age 41 of Hawley, PA was sentenced to the Wayne County Correctional Facility for a period of not less than 3 months nor more than 18 months for one count of Terroristic threats, graded as a Misdemeanor of the 1st Degree and one count of Recklessly Endangering Another Person, graded as a Misdemeanor of the 2nd Degree. He was also ordered to pay all Court costs, pay a fine in the amount of \$500.00, continue with mental health treatment, complete an anger management course, and obtain full time employment. The incident occurred on August 13, 2014 in Hawley Borough, PA.

**JOHN STANEK**, age 30 of Covington, PA was sentenced to the Wayne County Correctional Facility for a period of not less than 9 months nor more than 36 months for one count of Criminal Trespass, graded as a Felony of the 3rd Degree. He was also ordered to pay all Court costs, pay a fine in the amount of \$300.00, undergo a drug and alcohol evaluation and comply with all treatment recommendations, submit to the drawing of a DNA sample, and obtain full time employment. The incident occurred on September 7, 2014 in Palmyra Township, PA.
