May 28, 2015 — The following cases were addressed by the Robert J. Conway, Senior Judge, Wayne County:

DAVID R. EVARTS, age 49 of Lake Ariel, PA, was sentenced to a State Correctional Institution for a period of not less than 18 months nor more than 60 months, for one count of Possession of Controlled Substance With Intent to Deliver, graded as a Felony. He was also ordered to pay all Court costs and \$250.00 to the DNA Detection Fund. The incident occurred on November 21, 2014, in Salem Township, PA.

JEFFREY KNECHT, SR., age 39, of Tobyhanna, PA, was sentenced to a State Correctional Institution for a period of not less than 18 months nor more than 60 months, for one count of Possession With Intent to deliver-Cocaine, graded as a Felony. 
