#### CRIMINAL CASES

June 11, 2015 — The following cases were addressed by the Robert J. Conway, Senior Judge, Wayne County:

**EUGENE R. PRICE**, age 62, of Honesdale, PA, was sentenced to the Wayne County Correctional Facility for a period of not less than 9 months nor more than 60 months, less 1 day, for one count of Corruption of Minors, graded as a Misdemeanor of the 1st Degree. He was also ordered to pay all Court costs, pay for any victim counseling not to exceed \$2,500.00, pay a fine in the amount of \$500.00, have no contact with the victim, undergo a drug and alcohol evaluation and comply with all treatment recommendations, and undergo a sex offender evaluation while incarcerated and comply with recommendations for treatment. The incident occurred between July 2007 to July 2010, in Oregon Township, PA.

**DOMINICK DIMICK**, age 32, of Carbondale, PA, was sentenced to the Wayne County Correctional Facility for a period of not less than 76 days nor more than 5 years, less 1 day for one count of Theft by Unlawful Taking or Disposition, graded as a Misdemeanor of the 1st Degree. He was also ordered to pay all Court costs, pay a fine in the amount of \$300.00, pay restitution in the amount of \$13,917.67, perform 50 hours of community service, and obtain employment. The incident occurred between June 14, 2014 and February 3, 2015 in Berlin Township, PA.

**KENNETH MORGAN**, age 20, of Waymart, PA, was sentenced on two separate cases to the Wayne County Correctional Facility for a period of not less than 20 days nor more than 18 months for one count of DUI-Controlled Substance, an ungraded Misdemeanor and one count of Possession of Drug Paraphernalia, an ungraded Misdemeanor. He was also ordered to pay all Court costs, pay a fine in the amount of \$1,100.00, participate in the drug and alcohol addiction treatment, complete the Alcohol Highway Safety Program, and perform 50 hours of community service. The incidents occurred on October 19, 2014, and October 23, 2014, in Waymart Borough, PA.

GREGORY MULHOLLAND, age 54, of Milford, PA, was sentenced to the Wayne County Correctional Facility for a period of not less than 5 days, followed by 60 months less 5 days in the Intermediate Punishment Program for one count of DUI, graded as a Misdemeanor of the 1st Degree. He was also ordered to pay all Court costs, be placed on House Arrest with Electronic and Alcohol Monitoring for a period of 85 days, pay a fine in the amount \$1,500.00, undergo a drug and alcohol evaluation and comply with all treatment recommendations, complete the Alcohol Highway Safety Program, and continue with mental health treatment and comply with all treatment recommendations. The incident occurred on November 26, 2014, in Honesdale Borough, PA. His BAC was .259%.

He was also ordered to pay all Court costs, undergo a drug and alcohol evaluation and comply with treatment recommendations, and continue with mental health treatment. The incident occurred between November 25, 2014 and December 18, 2014, in Paupack Township, PA.

CHRISTOPHER BELL, age 25 of Jefferson Township, PA, was placed on the Accelerated Rehabilitative Disposition Program for a period of 6 months related to DUI.
