February 11, 2016 — The following cases were addressed by the Honorable Raymond L. Hamill, President Judge, Wayne County.

**TRACY LYNN BARBER**, age 42 of Milford, PA, was placed on probation for a period of 5 years for one count of Bad Checks, a Misdemeanor of the 1st Degree. She was also ordered to pay all Court costs, pay restitution in the amount of \$1,215.00, and obtain employment. The incident occurred on April 5, 2014, in Salem Township, PA.

**KATHLEEN ROSE MCINTOSH**, age 44 of Thompson, PA, was sentenced to the Wayne County Correctional Facility for a period of not less than 3 days nor more than 6 months for one count of DUI, an ungraded Misdemeanor, and one count of Driving Without a License, a Summary offense. He was also ordered to pay all Court costs, pay a fine in the amount of \$1,000.00, comply with all recommendations of your drug and alcohol assessment, perform 50 hours of community service, and complete the Alcohol Highway Safety Program. The incident occurred on July 25, 2015, in Honesdale Borough, PA. His BAC was .182%.

She was also ordered to pay all Court costs, pay a fine in the amount of \$300.00, comply with all recommendations of drug and alcohol assessment, undergo a mental health evaluation, and complete an anger management course. The incident occurred on October 8, 2015, in Clinton Township, PA.

**BRAD PASSINO**, age 50 of Scranton, PA, was placed on probation for a period of 24 months for one count of False Imprisonment, a Misdemeanor of the 2nd Degree. He was also ordered to pay all Court costs, pay restitution in the amount of \$157.09, and complete an anger management course. The incident occurred on June 27, 2015, in Honesdale Borough, PA.

**TODD WIGNALL JR.** age 20 of Gouldsboro, PA, was sentenced to the Wayne County Correctional Facility for a period of not less 2 months nor more than 23 1/2 months for

one count of Criminal Trespass-Enter Structure, a Felony of the 3rd Degree and one count of Theft by Unlawful Taking or Disposition, a Misdemeanor or the 1st Degree. He was also ordered to pay all Court costs, pay a fine in the amount of \$300.00, comply with all recommendations of drug and alcohol assessment, obtain full time employment, perform 100 hours of community service, and submit to the drawing of a DNA sample. The incident occurred on August 21, 2015, in Lehigh Township, PA.

DAVID EVARTS, age 49 of Lake Ariel, PA, was sentenced on two separate cases to a State Correctional Institution for a period of not less than 54 months nor more than 108 months for one count of Possession of Controlled Substance with Intent to Deliver, an ungraded Felony, one count of Possession of Drug Paraphernalia, an ungraded Misdemeanor, and three (3) counts of Possession of Controlled Substance, an ungraded Misdemeanor. He was also ordered to pay all Court costs and pay \$250 to the DNA Detection Fund. The incidents occurred on May 19, 2015 in Salem Township, PA, and on May 20, 2015 in Lake Township, PA. This sentence of 54 months to 108 months is in addition to the 18 to 60 months sentence the Defendant received on May 28, 2015, for Possession with Intent to Deliver Controlled Substances. The Defendant will now be serving a total sentence of 6 to 15 years.


