CRIMINAL CASES

June 23, 2016 — The following cases were addressed by the Honorable Raymond L. Hamill, President Judge, Wayne County.

ANDREW ARTLEY, age 27 of Hop Bottom, PA, was sentenced to the Wayne County Correctional Facility for a period of not less than 6 months nor more than 23 1/2 months for one count of Criminal Trespass-Break Into Structure, a Felony of the 3rd Degree. He was also ordered to pay all Court costs, pay \$250.00 to the DNA Detection fund, pay restitution in the amount of \$2,000.00, undergo a drug and alcohol evaluation, and undergo a mental health evaluation. The incident occurred on November 11, 2015, in Preston Township, PA.

LEROY CATANIA, age 31 of Honesdale, PA, was sentenced on two separate cases to the Wayne County Correctional Facility for a period of not less than 11 months nor more than 24 months less than one day for one count of Possession of Controlled Substance, an ungraded Misdemeanor, one count of Possession of Drug Paraphernalia, an ungraded Misdemeanor, one count of Possess, Use, Firearm, Etc., a Misdemeanor of the 1st Degree, one count of Unlawful Acts Concerning Licenses, one count of Taking/Possess of Game or Wildlife, one count of Unlawful Devices and Methods, and one count of Receiving Stolen Property, a Felony of the 3rd Degree. He was also ordered to pay all Court costs and pay a fine in the amount of \$1,550.00, pay restitution in the amount of \$1,000.00, undergo a drug and alcohol evaluation, and obtain full time employment. The incident occurred on November 1, 2015, in Damascus Township, PA.

GLENN COLBY, age 53 of Honesdale, PA, was sentenced to Wayne County Correctional Facility for a period of not less than 191 days nor more than 18 months for two counts of Possession of a Controlled Substance, an ungraded Misdemeanor. He was also ordered to pay all court costs and undergo drug and alcohol evaluation. The incident occurred on October 1st through the 23rd, 2015, in Berlin Township, PA.

STEPHANIE COLEMAN, age 27 of Glen Hope, PA, was sentenced to the Wayne County Correctional Facility for a period of not less than 10 days nor more than 6 months for one count of DUI, an ungraded misdemeanor. She was also ordered to pay all court costs, a fine in the amount of \$1,000.00, participate and cooperate with the drug and alcohol addiction treatment, complete the Alcohol Highway Safety Program, perform 50 hours of community service, and obtain full time employment. The incident occurred on June 20, 2015, in Sterling Township. Her BAC was Controlled Substance.

PATRICIA GREENWOOD, age 61 of Lake Ariel, PA was sentenced to the Wayne County Correctional Facility for a period of not less than 30 days nor more than 6 months for one count of Theft by Unlawful Taking or Disposition, a Misdemeanor of the 1st Degree. She was also ordered to pay all court costs, a fine in the amount of \$750.00, pay restitution in the amount of \$55,691.40, and perform 75 hours of community

service. The Defendant paid the \$55,691.40 in restitution prior to sentencing. The incident occurred on June 1, 2011 through November 6, 2015, in Lake Township.

JOHN HEDRICK, age 59 of Gouldsboro, PA was sentenced to the Wayne County Correctional Facility for a period of not less than 72 hours nor more than 6 months for one count of DUI, an ungraded Misdemeanor. He was also ordered to pay the court costs, pay a fine of \$1,000.00, be placed on alcohol monitoring through the SCRAM program for a period of 90 days, participate and corporate with the drug and alcohol treatment, and complete the Alcohol Highway Safety Program. The incident occurred on October 3, 2015, in Lehigh Township. His BAC was .212%.

DAWN MIMS, age 54 of Barryville, NY was sentenced to the Wayne County Correctional Facility for a period not less than 15 days followed immediately by 60 months less 15 days in the Intermediate Punishment Program for one count of DUI, a Misdemeanor of the 1st Degree. She was also ordered to pay all court costs, pay a fine of \$1,500.00, pay restitution in the amount of \$500.00, be placed on House Arrest with Electronic and Alcohol Monitoring through the SCRAM program for a period of 90 days, participate and cooperate in the drug and alcohol treatment, and complete Alcohol Highway Safety Program. The incident occurred on November 27, 2015, in Honesdale Borough, PA. Her BAC was Controlled Substance.

CHRISTOPHER PEPER, age 20 of Pleasant Mount, PA was placed on probation for a period of 12 months for one count of Open Lewdness, a Misdemeanor of the 3rd Degree. He was also ordered to pay all Court costs, and pay a fine in the amount of \$250, pay restitution in the amount of \$610.25, no contact with the minor victims and their family, and undergo a psychosexual risk assessment. The incident occurred on July 5, 2015, in Mount Pleasant Township, PA.

JEFFREY SULLIVAN, age 25 of Honesdale, PA was sentenced to the Wayne County Correctional Facility for a period not less than 18 days nor more than 12 months for one count of Possession of Controlled Substance, an ungraded Misdemeanor, and one count of DUI, an ungraded Misdemeanor. He was also ordered to pay all Court costs, pay a fine in the amount of \$1,000.00, undergo a drug and alcohol evaluation, perform 50 hours of community service, complete Alcohol Highway Safety Program, and resolve all warrants. The incident occurred on December 18, 2015, in Honesdale Borough. His BAC was Controlled Substance.

THOMAS CASPER, age 58 of Waymart, PA was placed on the Accelerated Rehabilitative Disposition Program for a period of 6 months related to DUI. He was also ordered to pay all Court costs and perform 40 hours of community service and have his operator's privilege suspended for 60 days. The incident occurred on August 21, 2015, in South Canaan Township, PA. His BAC was .112%.
