

CRIMINAL CASES

April 25, 2017 — The following cases were addressed by the Honorable Raymond L. Hamill, President Judge, Wayne County.

GRANT GILSON, age 30 of White Haven, PA, was sentenced on two separate cases to the Wayne County Correctional Facility for a period of not less than 6 months nor more than 12 months for two counts of Possession of Small Amount of Marijuana, an ungraded Misdemeanor, two counts of Possession of Drug Paraphernalia, an ungraded Misdemeanor, one count Driving Without a License, a Summary Offense, one count of Driving While Operating Privileges Suspended/Revoked, a Summary Offense, and one count of Driving on Roadways Laned for Traffic, a Summary Offense. He was also ordered to pay the costs of prosecution, pay fines in the total amount of \$425.00, undergo a drug and alcohol evaluation, and undergo a mental health evaluation. The incidents occurred on May 2, 2016 and May 3, 2016, in Salem Township and Paupack Township, PA.

JOHN CHAPMAN, age 44 of Lake Ariel, PA, was sentenced to the Wayne County Correctional Facility for a period of not less than 2 months nor more than 23 1/2 months for one count of Retail Theft, a Misdemeanor of the 1st Degree. He was also ordered to pay the costs of prosecution, and perform 50 hours of community service. The incident occurred on July 28, 2016, in Texas Township, PA.

JOSEPH CROWLEY, age 21 of Honesdale, PA, was sentenced to the Wayne County Correctional Facility for a period of not less than 15 days nor more than 23 1/2 months for one count of Receiving Stolen Property, a Misdemeanor of the 2nd Degree. He was also ordered to pay the costs of prosecution, pay a fine in the amount of \$200.00, continue with drug and alcohol treatment, perform 50 hours of community service, and obtain full time employment within 30 days of parole. The incident occurred on September 27, 2016, in Texas Township, PA.

THORNTON WELLS, age 27 of Hawley, PA was sentenced to the Wayne County Correctional Facility for a period of not less than 3 days nor more than 6 months for one count of DUI, an ungraded Misdemeanor. He was also ordered to pay the costs of prosecution, pay a fine in the amount of \$1,000.00, participate in and cooperate with the drug and alcohol addiction treatment, complete the Alcohol Highway Safety Program, perform 50 hours of community service. The incident occurred on September 17, 2016, in Palmyra Township, PA. His BAC was .170%.

POLLY WOOD, age 40 of Honesdale, PA, was placed on probation for a period of 6 months for one count of DUI, an ungraded Misdemeanor. She was also ordered to pay the costs of prosecution, pay a fine in the amount of \$300.00, participate in and cooperate with the drug and alcohol addiction treatment, complete the Alcohol Highway

Safety Program, perform 50 hours of community service, and maintain employment. The incident occurred on October 9, 2015, in Damascus Township, PA. Her BAC revealed Controlled Substance.

JOSEPH MAURIELLO, age 30 of Milford, PA, was placed on probation for a period of 6 months for one count of False Swearing in Official Proceeding, a Misdemeanor of the 2nd Degree. He was also ordered to pay the costs of prosecution, pay a fine in the amount of \$1,000.00, and undergo a drug and alcohol evaluation. The incident occurred on June 30, 2015, in Palmyra Township, PA.

April 27, 2017 — The following cases were addressed by the Raymond L. Hamill, President Judge, Wayne County:

MARIA ANN MILLER, age 52 of Beach Lake, PA, was sentenced to the Wayne County Correctional Facility for a period of not less than 72 hours nor more than 6 months for one count of DUI-Highest Rate, an ungraded Misdemeanor. She was also ordered to pay the costs of prosecution, pay a fine in the amount of \$1,000.00, participate in and cooperate with the drug and alcohol addiction, complete the Alcohol Highway Safety Program, and perform 50 hours of community service within 3 months. The incident occurred on September 17, 2016, in Berlin Township, PA. His BAC was .240%.

KAMIE HANSON, age 26 of South Sterling, PA, was sentenced to the Wayne County Correctional Facility for a period of not less than 48 hours nor more than 6 months for one count of DUI, an ungraded Misdemeanor and one count of Accident Involving Damage to Attended Vehicle/Property, a Misdemeanor of the 3rd Degree. She was also ordered to pay the costs of prosecution, pay a fine in the amount of \$500.00, participate in and cooperate with the drug and alcohol addiction treatment, and complete the Alcohol Highway Safety Program. The incident occurred on April 1, 2016, in Palmyra Township, PA. Her BAC was .112%

DANIEL FIGURA, age 18 of Honesdale, PA, was placed on the Accelerated Rehabilitative Disposition Program for a period of 6 months related to DUI. 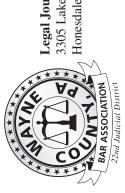
