

#### CRIMINAL CASES

June 15, 2017 — The following cases were addressed by the Honorable Raymond L. Hamill, President Judge, Wayne County.

VAN DOBISH, age 37 of Windsor, NY, was sentenced to Wayne County Correctional Facility for a period of not less than 6 months nor more than 23 1/2 months for one count of Criminal Conspiracy-Theft by Unlawful Taking or Disposition, a Misdemeanor of the 1st Degree. He was also ordered to pay the costs of prosecution, and undergo a drug and alcohol evaluation. The incident occurred between September 5, 2016, and October 3, 2016, in Starrucca Borough, PA.

**RYAN MERRING**, age 22 of Honesdale, PA, was placed on probation for a period of 12 months for one count of Possession of a Controlled Substance -Heroin, an ungraded Misdemeanor. He was also ordered to pay the costs of prosecution, pay a fine in the amount of \$500.00, continue with drug and alcohol treatment, perform 50 hours of community service, and maintain full time employment. The incident occurred on October 27, 2016, in Hawley Borough, PA.

JOHN DEMERS, age 45 of Gouldsboro, PA, was sentenced to the Wayne County Correctional Facility for a period of not less than 9 months nor more than 5 years for one count of DUI, a Misdemeanor of the 1st Degree. He was also ordered to pay the costs of prosecution, pay a fine in the amount of \$1,500.00, participate in and cooperate with the drug and alcohol addiction treatment, complete the Alcohol Highway Safety Program, perform 100 hours of community service within 6 months, and obtain full time employment within 30 days of parole. The incident occurred on September 16, 2016, in Lehigh Township, PA. His BAC revealed a .069% and Controlled Substances.

**DOMINICK MENOTTI**, age 25 of Chandler, AZ, was sentenced to the Wayne County Correctional Facility for a period of not less than 60 days nor more than 6 months for one count of DUI, an ungraded Misdemeanor, and one count of Driving While Operating Privilege Suspended/Revoked-DUI related, a Summary offense. He was also ordered to pay the costs of prosecution, pay a fine in the amount of \$750.00, participate in and cooperate with the drug and alcohol addiction treatment, and complete the Alcohol Highway Safety Program. The incident occurred on January 24, 2016, in Damascus Township, PA.

MICHAEL MANGIN, age 27 of Beach Lake, PA, was sentenced to the Wayne County Correctional Facility for a period of not less than 11 1/2 months nor more than 60 months less 1 day for one count of Possession with the Intent to Deliver-Heroin, an ungraded Felony. He was also ordered to pay the costs of prosecution, continue with drug and alcohol treatment, continue with mental health treatment, and perform 100 hours of community service within 6 months. The incident occurred on December 17, 2016, in Honesdale Borough, PA.

**STEVEN ESTUS**, age 31 of Moscow, PA, was sentenced, on two separate cases, to the Wayne County Correctional Facility for a period of not less than 12 months nor more than 60 months less 1 day for one count of Receiving Stolen Property, a Misdemeanor of the 1st Degree, one count of Criminal Attempt/Theft from a Motor Vehicle, a Misdemeanor

of the 3rd Degree, one count of Criminal Trespass, a Felony of the 3rd Degree, and one count of Theft by Unlawful Taking or Disposition, a Misdemeanor of the 1st Degree. He was also ordered to pay the costs of prosecution, pay a fine in the amount of \$500.00, pay restitution in the amount of \$815.00, submit to the drawing of a DNA sample, undergo a drug and alcohol evaluation, and undergo a mental health evaluation. The incidents occurred on December 19, 2016, and January 24, 2017, in Salem Township, PA.

**TERRI WICKS**, age 52 of Richey, FL, was placed on probation for a period of 18 months for one count of Simple Assault, a Misdemeanor of the 2nd Degree, one count of Disorderly Conduct, a Misdemeanor of the 3rd Degree, and one count of Harassment, a Summary offense. She was also ordered to pay the costs of prosecution, pay a fine in the amount of \$50.00, undergo a drug and alcohol evaluation, continue with mental health treatment, and complete an anger management course. The incident occurred on October 18, 2016, in Texas Township, PA.

WILLIAM GILPIN, age 43 of Lake Ariel, PA, was sentenced, on two separate cases, to the Wayne County Correctional Facility for a period of not less than 8 days nor more than 12 months for one count of DUI, an ungraded Misdemeanor, and one count of Home Improvement Fraud, a Misdemeanor of the 1st Degree. He was also ordered to pay the costs of prosecution, pay a fine in the amount of \$500.00, participate in and cooperate with the drug and alcohol addiction treatment, complete the Alcohol Highway Safety Program, pay restitution in the amount of \$630.00, and perform 50 hours of community service within 3 months.

**DONNA BRENNAN**, age 30 of Hamlin, PA, was sentenced to the Wayne County Correctional Facility for a period of not less than 49 days nor more than 12 months for one count of Disorderly Conduct, a Misdemeanor of the 3rd Degree. She was also ordered to pay the costs of prosecution, immediately upon parole be placed on 30 days of GPS Electronic Monitoring, and undergo a drug and alcohol evaluation. The incident occurred on April 28, 2016, in Lake Township, PA.

MARK EDWARD WORK, age 59 of Jefferson Township, PA, was sentenced to the Wayne County Correctional Facility for a period of not less than 10 days followed immediately by 6 months less 10 days, in the Intermediate Punishment Program. He was also ordered to pay the costs of prosecution, pay a fine in the amount of \$750.00, be placed on House Arrest with Electronic and Alcohol Monitoring through the SCRAM Program for a period of 20 days, pay restitution in the amount of \$516.60, comply with all treatment recommendations in accordance with the drug and alcohol assessment, and complete the Alcohol Highway Safety Program. The incident occurred on December 23, 2016, in Dreher Township, PA. His BAC revealed a .129%.

**BRIAN JOPP**, age 48 of Waymart, PA, was placed on the Accelerated Rehabilitative Disposition Program for a period of 6 months related to DUI. He was also ordered to pay all Court costs and have his operator's privileges suspended for 60 days. The incident occurred on November 4, 2016, in Cherry Ridge Township PA. His BAC revealed a .16%.

JAMES O'CONNELL, age 29 of Honesdale, PA, was placed on the Accelerated Rehabilitative Disposition Program for a period of 6 months related to Possession of Drug Paraphernalia. He was also ordered to pay all Court costs and perform 40 hours of community service. The incident occurred on March 26, 2017, in Palmyra Township PA.
