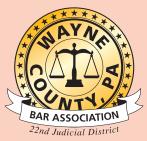



CRIMINAL CASES

June 29, 2017 — The following cases were addressed by the Honorable Raymond L. Hamill, President Judge, Wayne County.

LINDSEY CARMODY, age 21 of Honesdale, PA, was placed on probation for a period of 15 months for one count of Unlawful Restraint, a Misdemeanor of the 1st Degree, one count of Terroristic Threats, a Misdemeanor of the 1st Degree, and one count of Simple Assault, a Misdemeanor of the 2nd Degree. She was also ordered to pay the costs of prosecution, pay fines in the total amount of \$300.00, have no contact with the victim, continue with drug and alcohol treatment, and continue with mental health treatment. The incident occurred on November 2, 2016, in Honesdale Borough, PA.

ASHLEY MUNOZ, age 19 of Hawley, PA, was placed on probation for a period of 12 months for one count of False Reports to Law Enforcement Authorities, a Misdemeanor of the 2nd Degree. She was also ordered to pay the costs of prosecution and comply with all recommendations of the drug and alcohol assessment. The incident occurred on October 27, 2016, in Texas Township, PA.



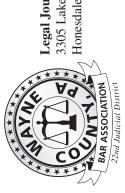
