

## **CRIMINAL CASES**

*The following cases were addressed by the Honorable Raymond L. Hamill, President Judge, Wayne County:* 

#### HONESDALE, PA - October 26, 2017

**KATHRYN MILLS**, age 29 of Duryea, PA, was sentenced to the Wayne County Correctional Facility for a period of not less than 1 month nor more than 36 months for one count of Forgery, a Felony of the 3rd Degree. She was also ordered to pay the costs of prosecution, pay restitution in the amount of \$2,744.00, undergo a drug and alcohol assessment, and submit to the drawing of a DNA sample and pay for the cost. The incident occurred on April 22, 2017, in Lehigh Township, PA.

**JAMES PAUL SMITH**, age 57 of Beach Lake, PA, was sentenced to the Wayne County Correctional Facility for a period of not less than 30 days followed immediately by 60 months less 30 days in the Intermediate Punishment Program for one count of DUI, a Misdemeanor of the 1st Degree. He was also ordered to pay the costs of prosecution, pay fine in the amount of \$1,500.00, be placed on House Arrest and Alcohol Monitoring through the SCRAM Program for a period of 6 months, participate in and cooperate with the drug and alcohol addiction treatment, complete the Alcohol Highway Safety Program, and perform 100 hours of community service. The incident occurred on February 3, 2017, in Berlin Township, PA. His BAC revealed a .214%.

**KRISTOPHER SLOCUM**, age 44 of Lake Como, PA, was sentenced to the Wayne County Correctional Facility for a period of not less than 12 months nor more than 60 months, less 1 day for one count of Possession of Controlled Substance with Intent to Deliver-Crystal Methamphetamine, an ungraded Felony, and one count of Corruption of Minors, a Misdemeanor of the 1st Degree. He was also ordered to pay the costs of prosecution, pay a fine in the amount of \$1,000.00, undergo a drug and alcohol evaluation, and submit to the drawing of a DNA sample, and \$250.00 for the cost. The incident occurred on May 19, 2017, in Preston Township, PA.

**RUSSELL FINE**, age 36 of Beach Lake, PA, was sentenced to the Wayne County Correctional Facility for a period of not less than 10 days, followed immediately by 60 months less 10 days in the Intermediate Punishment Program for one count of DUI, a Misdemeanor of the 1st Degree. He was also ordered to pay the costs of prosecution, pay a fine in the amount of \$1,500.00, be placed on House Arrest with Electronic and Alcohol monitoring through the SCRAM program for a period of 90 days, participate in and cooperate with the drug and alcohol addiction treatment, complete the Alcohol Highway Safety Program, and perform 100 hours of community service. The incident occurred on March 11, 2017, in Honesdale Borough, PA. His BAC revealed a .214%.

**RYAN KARPOVICH**, age 19 of Greentown, PA, was sentenced to the Wayne County Correctional Facility for a period of not less than 9 months nor more than 36 months for one count of Criminal Trespass, a Felony of the 2nd Degree. He was also ordered to pay the costs of prosecution, undergo a drug and alcohol evaluation, comply with all recommendations of the drug and alcohol assessment, undergo a mental health evaluation, obtain employment within 30 days of parole, and submit to the drawing of a DNA sample and pay \$250.00 for the cost. The incident occurred on February 13, 2017, in Texas Township, PA.

**SUSAN FRESHOUR**, age 51 of Honesdale, PA, was placed on probation for 12 months for one count of Identity Theft, a Misdemeanor of the 1st Degree. She was also ordered to pay the costs of prosecution, pay a fine in the amount of \$200.00, continue with mental health treatment, obtain employment within 45 days of sentence, and resolve all outstanding warrants within 60 days of sentence. The incident occurred on January 24, 2017, in Honesdale Borough, PA.

**TIMOTHY KOHRS**, age 63 of Honesdale PA, was placed on the Accelerated Rehabilitative Disposition Program for a period of 6 months related to DUI. He was also ordered to pay all Court costs and perform 40 hours of community service and have his operator's privilege suspended for 30 days. The incident occurred on April 7, 2017, Dyberry Township, PA. His BAC revealed a .15%.

**COREY TEEPLE**, age 24 of Lake Ariel PA, was placed on the Accelerated Rehabilitative Disposition Program for a period of 6 months related to DUI. He was also ordered to pay all Court costs and perform 40 hours of community service and have his operator's privilege suspended for 60 days. The incident occurred on June 2, 2017, Cherry Ridge Township, PA. His BAC revealed a .216%.

**BROOKE NUTT**, age 20 of Hawley PA, was placed on the Accelerated Rehabilitative Disposition Program for a period of 6 months related to Possession of Small Amount. She was also ordered to pay all Court costs and perform 40 hours of community service. The incident occurred on April 8, 2017, Texas Township, PA.


