#### HONESDALE, PA — November 1, 2017

MICHAEL WORMUTH, age 39 of Throop, PA, was sentenced to the Wayne County Correctional Facility for a period of not less than 103 days nor more than 12 months for one count of Possession of Drug Paraphernalia, an ungraded Misdemeanor and one count of Driving Without a License, a Summary offense. He was also ordered to pay the costs of prosecution, pay a fine in the amount of \$200.00, and undergo a drug and alcohol evaluation. The incident occurred on August 31, 2016, in Prompton Borough, PA.

#### HONESDALE, PA — November 2, 2017

JAMEL THOMAS, age 38 of Valley Stream, NY, was sentenced to the Wayne County Correctional Facility for a period of not less than 15 days nor more than 12 months for one count of Simple Assault, a Misdemeanor of the 2nd Degree. He was also ordered to pay the costs of prosecution, pay a fine in the amount of \$300.00, undergo a drug and alcohol evaluation, undergo a mental health evaluation, complete an anger management course, and obtain employment within 30 days of parole. The incident occurred on March 30, 2015, in Honesdale Borough, PA.

JOHN LUNSFORD, age 41 of Bear, DE, was sentenced to the Wayne County Correctional Facility for a period of not less than 10 days followed immediately by 6 months, less 10 days in the Intermediate Punishment Program, for one count of DUI, an ungraded Misdemeanor. He was also ordered to pay the costs of prosecution, pay a fine in the amount of \$750.00, be placed on House Arrest with Electronic and Alcohol Monitoring through the SCRAM Program for a period of 60 days, pay restitution in the amount of \$40.00, participate in and cooperate with the drug and alcohol addiction treatment, complete the Alcohol Highway Safety Program, and perform 40 hours of community service. The incident occurred on February 17, 2017, in Salem Township, PA. His BAC was .242%.

**JEREMIAH FRANK GUTHRIE**, age 48 of Honesdale, PA, was sentenced to the Wayne County Correctional Facility for a period of not less than 10 months nor more than 24 months for one count of Indecent Exposure, a Misdemeanor of the 2nd Degree. He was also ordered to pay the costs of prosecution, undergo a drug and alcohol evaluation, undergo a psychosexual risk assessment within 30 days of parole, and maintain employment while on parole. The incident occurred on March 30, 2017, in Texas Township, PA.

**IAN HOUGHTALING**, age 35 of Damascus, PA, was sentenced to the Wayne County Correctional Facility for a period of not less than 10 months nor more than 24 months

for one count of DUI, an ungraded Misdemeanor, and one count of Endangering the Welfare of Children as a Parent/Guardian, a Misdemeanor of the 1st Degree. He was also ordered to pay the costs of prosecution, pay a fine in the amount of \$1,000.00, participate in and cooperate with drug and alcohol addiction treatment, and complete the Alcohol Highway Safety Program. The incident occurred on January 10, 2017, in Cherry Ridge Township, PA. His BAC revealed Controlled Substances.

**CAYLYN CARROL**, age 31 of Reading, PA, was sentenced to the Wayne County Correctional Facility for a period of not less than 2 month nor more than 18 months for one count of Retail Theft, a Misdemeanor of the 2nd Degree. She was also ordered to pay the costs of prosecution, pay restitution in the amount of \$9.52, undergo a drug and alcohol evaluation, and undergo a mental health evaluation. The incident occurred on September 22, 2016, in Palmyra Township, PA.

**ROXANE MARIA ROSSI MILLS**, age 53 of Lake Ariel, PA, was placed on probation for a period of 6 months for one count of Defiant Trespass, a Misdemeanor of the 3rd Degree. She was also ordered to pay the costs of prosecution, and pay restitution in the amount of \$446.10. The incident occurred on December 2, 2016, in Texas Township, PA.

WILLIAM L. CURE, age 43 of Milford, PA, was sentenced to the Wayne County Correctional Facility for a period of 90 days followed by 60 months in the Intermediate Punishment Program for one count of DUI, graded as a Misdemeanor of the 1st Degree. He was also ordered to pay the costs of prosecution, pay a fine in the amount of \$1,500.00, be placed on House Arrest with Electronic and Alcohol Monitoring through the SCRAM program for a period of 90 days, participate in and cooperate with drug and alcohol addiction treatment and complete the Alcohol Highway Safety Program. The incident occurred on March 3, 2017, in Clinton Township. His BAC was .240%.

**JONATHAN BRADY**, age 23 of Lake Ariel, PA, was placed on the Accelerated Rehabilitative Disposition Program for a period of 6 months related to Fleeing or Attempting to Elude a Police Officer. Defendant also plead guilty to one count of Exceeding Maximum Speed Limits Graded as a Summary. He was also ordered to pay all Court costs, perform 40 hours of community service. The incident occurred on April 12, 2017, in Salem Township, PA. His BAC was .061%.

#### DISTRICT ATTORNEY'S OFFICE — PRESS RELEASE

#### **Major Drug Dealer Arrested**

October 31, 2017 — Janine Edwards, Wayne County District Attorney, announced today the arrest of John Joseph Henneforth Jr., age 38 of Greentown, Pennsylvania. Henneforth is charged with Delivery of Heroin (F), Criminal Use of Communication Facility (F), and Possession of Heroin (M). Henneforth made the sale of 10 bags of Heroin to a Confidential Informant of the Wayne County District Attorney's Drug Task Force this month. Henneforth is a suspect in large scale drug deal ring in Wayne County.

Henneforth's bail was set at \$250,000.00 by District Magisterial Judge Linus Myers. Henneforth is currently on State Parole for a previous conviction in 2013 for



Delivery of Heroin (F) and related drug offenses. Henneforth is scheduled for an appearance at Central Court at 9:00 a.m. on Wednesday, November 8, 2017 at the Wayne County Courthouse.

Janine Edwards stated "The heroin problem must be addressed with a combination of education of our youth, treatment of those addicted and prosecution of drug dealers. Safety of our towns and our residents must come first. Drug dealing always brings with it crime. Today's charge is a great step in arresting dealers who sell large amounts of drugs in our county. Various law enforcement officers joined the Wayne

County District Attorney's Drug Task Force in this investigation. Agencies represented in this investigation are the Pennsylvania State Police, the Pike County Detectives Office, the Honesdale Borough Police Department and the Waymart Borough Police Department."

The filing of criminal charges in not evidence of guilt but simply a description of the charge made by the Commonwealth against a defendant. A charged Defendant is presumed innocent until a jury returns a unanimous finding that the Commonwealth has proven the defendant's guilt beyond a reasonable doubt or until the defendant enters a guilty plea to the charges.
