#### CRIMINAL CASES

The following cases were addressed by the Honorable Raymond L. Hamill, President Judge, Wayne County:

#### HONESDALE, PA - November 30, 2017

**BOBIE JO CATANIA**, age 33 of Honesdale, PA, was placed on probation for a period of 12 months for one count of Retail Theft, a Misdemeanor of the 2nd Degree. She was also ordered to pay the costs of prosecution, pay restitution in the amount of \$334.79 jointly and severally with co-defendant, continue to comply with all drug and alcohol treatment, and obtain employment within 30 days. The incident occurred on May 22, 2017, in Texas Township, PA.

WILLIAM JOSEPH COOPER, age 45 of Beach Lake, PA, was sentenced to the Wayne County Correctional Facility for a period of not less than 80 days nor more than 23 1/2 months for one count of Simple Assault, a Misdemeanor of the 2nd Degree. He was also ordered to pay the costs of prosecution, pay a fine in the amount of \$300.00, undergo a drug and alcohol evaluation, refrain from having contact with the victim while on parole, complete an anger management course, and maintain full time employment. The incident occurred on July 25, 2017, in Honesdale Borough, PA.

PAUL FRANCIS CARTE, age 54 of Lakeville, PA, was sentenced to the Wayne County Correctional Facility for a period of not less than 6 months nor more than 18 months for one count of Simple Assault, a Misdemeanor of the 2nd Degree. He was also ordered to pay the costs of prosecution, pay a fine in the amount of \$500.00, undergo a drug and alcohol evaluation, and complete an anger management course. The incident occurred on December 16, 2016, in Salem Township, PA.

**ELIZABETH RIKER**, age 21 of Hawley, PA, was sentenced to the Wayne County Correctional Facility for a period not less than 2 months not more than 12 months for one count of Possession of Drug Paraphernalia, an ungraded Misdemeanor. She was also ordered to pay the costs of prosecution and undergo a drug and alcohol evaluation. The incident occurred on June 2, 2017, in Texas Township, PA.

STEVEN FRANK CASAZZA, age 58 of Honesdale, PA, was sentenced to the Wayne County Correctional Facility for a period of not less than 7 months nor more than 42 months for one count of Fleeing or Attempting to Elude a Police Officer, a Felony of the 3rd Degree, one count of Recklessly Endangering Another Person, a Misdemeanor of the 2nd Degree, one count of False Identification to Law Authorities, a Misdemeanor of the 3rd Degree, and one count of Possession of Controlled Substance, a an ungraded Misdemeanor. He was also ordered to pay the costs of prosecution, pay a fine in the amount of \$25.00, submit to the drawing of a DNA sample, undergo a drug and alcohol

evaluation, receive a mental health evaluation while incarcerated, and obtain employment within 30 days of parole. The incident occurred on June 1, 2017, in Paupack Township, PA.

JAMES CAVALCANTE, age 61 of Bayonne, NJ was sentenced to the Wayne County Correctional Facility for a period of not less than 3 days nor more than 6 months for one count of DUI, an ungraded Misdemeanor. He was also ordered to pay the costs of prosecution, pay a fine in the amount of \$1,500.00, undergo a drug and alcohol evaluation, and complete the Alcohol Highway Safety Program. The incident occurred on May 4 017, in Palmyra Township, PA. His BAC revealed a .185%.

MORGAN KROM, age 23 of Honesdale, PA, was placed on the Accelerated Rehabilitative Disposition Program for a period of 6 months related to DUI. He was also ordered to pay all Court costs and perform 40 hours of community service and have his operator's privilege suspended for a period of 60 days. 
