#### CRIMINAL CASES

The following cases were addressed by the <u>Honorable Raymond L. Hamill, Senior Judge</u>. Wayne County:

#### HONESDALE, PA — March 8, 2018

WALTER KORMAN, age 63 of Damascus, PA was sentenced to probation for a period of 6 months for one count of Possession of Controlled Substance-Marijuana, an ungraded Misdemeanor. He was also ordered to pay the costs of prosecution, pay a fine in the amount of \$300.00, undergo a drug and alcohol evaluation, and continue with mental health treatment. The incident occurred on December 8, 2017, in Damascus Township, Wayne County, PA.

**CHRISTINA FARRACHI**, age 26 of Lake Ariel, PA, was sentenced to the Wayne County Correctional Facility for a period of not less than 30 days followed immediately by 12 months less 30 days in the Intermediate Punishment Program. She was also ordered to pay the costs of prosecution, be placed on GPS monitoring for a period of 90 days, and undergo a drug and alcohol evaluation. The incident occurred on September 24, 2017, in Palmyra Township, Wayne County, PA.

**ADAM VITIELLO**, age 31 of Hawley, PA, was placed on the Accelerated Rehabilitative Disposition Program for a period of 6 months related DUI. He was also ordered to pay all Court costs and perform 40 hours of community service and have his operator's privilege suspended for 30 days. The incident occurred on May 27, 2017 in Hawley Borough, Wayne County, PA. His BAC was a .140%.

**KENTRINA KIMBALL**, age 31 of Honesdale, PA, was placed on the Accelerated Rehabilitative Disposition Program for a period of 6 months related DUI. She was also ordered to pay all Court costs and perform 40 hours of community service and have her operator's privilege suspended for 60 days. The incident occurred on April 5, 2017 in Berlin Township, Wayne County PA. Her blood draw tested positive for Controlled Substance.


