GOOD NEWS RE WCBA'S PRO BONO PROGRAM

April 13,2018

To all Members of the Wayne County Bar Association:

Last year, as we were developing our new pro bono plan, we identified contested custody and abuse cases as the #1 unmet need for legal services by the poor in our county. We didn't have all that many of our lawyers willing to take these cases on pro bono, so we decided to try "low bono". We formed a not-for-profit subsidiary (Pro Bono Partnerships) that can fundraise and accept charitable contributions, applied to IOLTA for a \$20,000 grant, and last month, voted to transfer the first \$10,000 from our funds to it. John Martin has agreed to lead the effort to raise funds from the community to support it, and we should hear from IOLTA about our grant by the end of next month.

I am very pleased to report that earlier this week, we decided to award the first two lowbono contracts: to attorneys Lindsey Collins and Mike Parley. Both candidates impressed the Board with how thoughtful they were in assessing the situation and with their commitment to the cause. We are now in the process of finalizing the contracts with them and setting up the referral process from North Perm Legal Services, Victims Intervention Program, and our Custody Masters, and should be ready to start accepting referrals by the end of this month.

Ours has been called one of the most exciting new pro bono programs in Pennsylvania in recent years. Please join me in thanking Lindsey and Mike and do what you can to help them succeed with this important part of our service to the public. And if you are so inclined, make a financial contribution to Pro Bono Partnerships to help support this work (checks can be sent to our Treasurer, Brendan Ellis).

DRUG DEALER SENTENCED TO 21-42 MONTHS

April 12, 2018 — Patrick L. Robinson, Wayne County District Attorney, announced today that John Henneforth Jr, age 39 of Greentown, Pennsylvania was sentenced to 21 months to 42 months in a State Correctional Institution for one count of Criminal Use of a Communication Facility, a Felony. Senior Judge Raymond Hamill sentenced Henneforth in the Aggravated Range of the Sentencing Guidelines because Henneforth



was on State Parole in October 2017 when he committed the offense. This sentence was consecutive (in addition) to Henneforth's four (4) prior drug convictions. Henneforth's maximum date of release on his four (4) prior drug convictions is August 28, 2022. The Wayne County Drug Task Force (WCDTF) conducted the investigation which resulted in Henneforth's arrest in October 2017.

District Attorney Robinson stated, "Mr. Henneforth has been a drug dealer, on and off, in Wayne County for the past six (6) years. The best place for him is in a State Correctional Institution. I will oppose any future paroles or early releases for Mr. Henneforth."

HONESDALE, PA — April 12, 2018

ROBERT FRANK SCHAFFER, age 34 of Spring Brook Township, PA was sentenced to the Wayne County Correctional Facility for a period of not less than 30 days nor more than 60 months less 1 day for one count of Theft By Unlawful Taking or Disposition, a Misdemeanor of the 1st Degree. He was also ordered to pay the costs of prosecution, pay restitution in the amount of \$30,429.89, comply with all recommendations of his drug and alcohol assessment, perform 50 hours of community service within 6 months, and maintain employment. The incident occurred on October 23, 2017, in Salem Township, Wayne County, PA.

SHAUN WUTCHER, age 37 of Greentown, PA was sentenced to the Wayne County Correctional Facility for a period of not less than 3 months nor more than 6 months for one count of DUI, an ungraded Misdemeanor. He was also ordered to pay the costs of prosecution, pay a fine in the amount of \$500.00, participate in and cooperate with the drug and alcohol addiction treatment, complete the Alcohol Highway Safety Program, and obtain employment within 30 days of parole. The incident occurred on August 5, 2017, in Hawley Borough, Wayne County, PA. His BAC revealed a .156%.

LINDA AMOS, age 56 of Lake Ariel, PA, was placed on probation for a period of 6 months for one count of DUI, an ungraded Misdemeanor. She was also ordered to pay the costs of prosecution, pay a fine in the amount of \$300.00, pay restitution in the amount of \$9,862.00, participate in and cooperate with the drug and alcohol addiction treatment, complete the Alcohol Highway Safety Program, and perform 50 hours of community service. The incident occurred on June 26, 2017, in Salem Township, Wayne County, PA. Her BAC revealed a .085%.

FATIMA PEREZ, age 62 of Lake Ariel, PA was placed on probation for a period of 6 months for one count of Bad Checks, a Misdemeanor of the 3rd Degree. She was also ordered to pay the costs of prosecution and pay a fine in the amount of \$200.00. The incident occurred on April 17, 2017, in Salem Township, Wayne County, PA.

ROY HOLM, age 30 of Honesdale, PA was sentenced to the Wayne County Correctional Facility for a period of 5 days followed immediately by 6 months less 5 day in the Intermediate Punishment Program for one count of Dui, an ungraded Misdemeanor. He was also ordered to pay the costs of prosecution, pay a fine in the

amount of \$750.00, be placed on House Arrest with Electronic and Alcohol Monitoring through the SCRAM Program for a period of 25 days, participate in and cooperate with the drug and alcohol addiction treatment, complete the Alcohol Highway Safety Program, and obtain employment within 45 days of parole. The incident occurred on September 3, 3017, in Cherry Ridge Township, Wayne County, PA. His BAC revealed a .159%.

IAN HOUGHTALING, age 35 of Damascus, PA was sentenced to the Wayne County Correctional Facility for a period of not less than 14 months nor more than 48 months for one count of Criminal Trespass-Enter Structure, a Felony of the 3rd Degree. He was also ordered to pay the costs of prosecution, participate in and cooperate with the drug and alcohol addiction treatment, refrain from contact with the victim while on parole, and obtain employment within 30 days of parole. The incident occurred on August 28, 2017, in Damascus Township, Wayne County, PA.

STEVEN NUSS, age 24 of Honesdale, PA was sentenced to the Wayne County Correctional Facility for a period of not less than 3 days nor more than 6 months for one count of DUI, an ungraded Misdemeanor and one count of Accident Involving Damage to Attended Vehicle/Property, a Misdemeanor of the 3rd Degree. He was also ordered to pay the costs of prosecution, pay a fine in the amount of \$1,000.00, participate in and cooperate with drug and alcohol addiction treatment, complete the Alcohol Highway Safety Program, and continue with mental health treatment. The incident occurred on October 21, 2017, in Honesdale Borough, Wayne County, PA. He refused a blood test.
