The following cases were addressed by the Honorable <u>Raymond L. Hamill, Senior Judge</u>, Wayne County:

HONESDALE, PA — June 28, 2018

PETER JOHN TOMASETTI, age 19 of Lake Ariel, PA was placed on probation for a period of 24 months, for one count of Corruptions of Minors (M1). He was also ordered to pay the costs of prosecution, pay a fine in the amount of \$250.00, pay restitution for any victim counseling not to exceed \$10,000.00, no contact with the victim, no unsupervised contact with any child under the age of 18, undergo a psychosexual risk assessment within 30 days of sentencing, and maintain full time employment or full time student status. The incident occurred between August 30, 2017 and September 2, 2017, in Salem Township, Wayne County, PA.

ROBERT KUESTER, age 23 of Honesdale, PA was placed on probation for a period of 18 months for tow counts of Possession of Drug Paraphernalia (M). He was also ordered to pay the costs of prosecution, undergo a drug and alcohol evaluation, and obtain employment within 30 days of sentence. The incidents occurred on August 17, 2017in Texas Township, Wayne County and on January 9, 2018, in Honesdale Borough, Wayne County, PA.

DESTINY FRASCHILLA, age 22 of Waymart, PA, was sentenced to the Wayne County Correctional Facility for a period of not less than 48 hours nor more than 6 months, followed by 12 months of probation for one count of DUI (M) and three counts of Possession of Drug Paraphernalia (M). She was also ordered to pay the costs of prosecution, pay a fine in the amount of \$1,000.00, complete the Alcohol Highway Safety Program, participate in and cooperate with the drug and alcohol addiction treatment, and obtain full time employment within 30 days of sentence. The incidents occurred on September 29, 2017, in Palmyra Township, Wayne County, on October 13, 2017, in Honesdale Borough, Wayne County, and on October 29, 2017, in Honesdale Borough, Wayne County, PA. Her blood test revealed a Controlled Substance.

BRITTANI GILPIN, age 30 of Moscow, PA, was placed on probation for a period of 12 months for one count of Possession of Controlled Substance (M). She was also ordered to pay the costs of prosecution, pay a fine in the amount of \$200.00, undergo a drug and alcohol evaluation, perform 50 hours of community service, and maintain employment. The incident occurred on October 11, 2017, in Texas Township, Wayne County, PA.

DEENA WHITFIELD, age 33 of Lake Ariel, PA, was sentenced to the Wayne County Correctional Facility for a period of not less than 5 days nor more than 6 months for one

count of DUI (M) and one count of Driving While Operating Privilege Suspended/Revoked (S). She was also pay the costs of prosecution, pay a fine in the amount of \$700.00, participate in and cooperate with the drug and alcohol addiction, complete the Alcohol Highway Safety Program, and perform 50 hours of community service within 3 months. The incident occurred on April 8, 2017, in Texas Township, Wayne County, PA. Her BAC revealed a .145%.

RICHARD SOUDER, age 27 of egg Harbor, NJ was sentenced to a State Correctional Institution for a period of not less than 12 months nor more than 60 months for one count of Forgery (F3). He was also ordered to pay the costs of prosecution, pay restitution in the amount of \$2,160.09, and submit to the drawing of a DNA sample, and pay \$250.00 for the cost. The incident occurred on January 24, 2017, in Lehigh Township, Wayne County, PA.

MICHAEL KEANE, age 27 of Hawley, PA was sentenced to the Wayne County Correctional Facility for a period of not less than 12 months nor more than 36 months for one count of Delivery of Controlled Substance-Heroin (F). He was also ordered to pay the costs of prosecution, pay a fine in the amount of \$1,000.00, resolve all warrants within 30 days of parole, undergo a drug and alcohol evaluation, perform 100 hours of community service, and submit to the drawing of a DNA sample, and pay \$250.00 for the cost. The incident occurred on April 25, 2017, in Paupack Township, Wayne County, PA.

FAITH COLLINS, age 25 of Ashely, PA was placed in the Intermediate Punishment Program for a period of 36 months for one count of Theft by Unlawful Taking or Disposition (F3). She was also ordered to pay the costs of prosecution, pay restitution in the amount of \$1,800.00, be placed on Electronic GPS Monitoring for a period of 6 months, undergo a drug and alcohol evaluation, and submit to the drawing of a DNA sample and \$250.00 for the cost. The incident occurred between December 16, 2016 and January 8, 2017, in Honesdale Borough, Wayne County, PA.

JAMES WEBB, age 28 of Cleveland, OH was sentenced to a State Correctional Institution for a period of not less than 6 months nor more than 36 months for one count of Receiving Stolen Property (M1). He was also ordered to pay the costs of prosecution and pay restitution in the amount of \$1,017.54. The incident occurred on March 26, 2015, in Texas Township, Wayne County, PA.

JOSEPH WOLFE, age 32 of Lake Ariel, PA was sentenced to the Wayne County Correctional Facility for a period of not less than 1 month nor more than 18 months for two counts of Theft by Deception-False Impression (M2). He was also ordered to pay the costs of prosecution, pay restitution in the amount of \$2,850.00, undergo a drug and alcohol evaluation, undergo a mental health evaluation, and resolve all outstanding warrants within 60 months. The incident occurred on September 7, 2017, in Lake Township, Wayne County, PA.

STATE SENTENCE FOR ARMED ROBBERY

June 29, 2018 — Patrick L. Robinson, Wayne County District Attorney announced that Kelley Elizabeth Branning, age 30, was sentenced to incarceration in a State Correctional Institution for a period of 40 months to 96 months for Robbery. Branning robbed the China Castle Restaurant on Main Street in Honesdale on December 18, 2017. She wore a mask and brandished a hand gun. She handed the restaurant owner a note demanding money. She stole approximately \$347.00.

The Honesdale Borough Police Department investigated the robbery and arrested Branning on December 21, 2017. Branning pleaded guilty to Robbery (Threatened Serious Bodily Injury) a Felony of the 1st Degree.

District Attorney Robinson stated, "It was clear that the defendant Branning was

very remorseful for her actions. The hand gun used by Branning was ultimately located and was a pellet gun. While Branning claimed she had no intent to harm anyone, her actions on December 18, 2017, were extremely dangerous. The restaurant owner could very easily have been armed, a patron could have been armed, or the responding police were obviously armed. Branning could have easily have been shot or an innocent bystander could have been hit by a stray bullet. In any event the restaurant owner was extremely frightened in this episode."

"On Thursday we had over 30 cases of Sentencings and Guilty Pleas. Of those cases well over 50% were in some way drug related. In this case Branning robbed the China Castle

restaurant in order to get money to buy Cocaine."

"The Honesdale Borough Police did an excellent job investigating this robbery."
