#### CRIMINAL CASES

The following cases were addressed by the Honorable <u>Raymond L. Hamill, Senior Judge</u>, Wayne County:

#### HONESDALE, PA — July 5, 2018

VICTORIA ZIPPERLEN, age 25 of Hawley, PA was sentenced to the Wayne County Correctional Facility for a period of not less than 1 month nor more than 23 1/2 months for one count of Criminal Use of a Communication Facility (F3). She was also ordered to pay the costs of prosecution, undergo a drug and alcohol evaluation, perform 50 hours of community service, and submit to the drawing of a DNA sample, and pay \$250.00 for the cost. The incident occurred between November 12, 2017 and November 20, 2017, in Berlin Township, Wayne County.

**DREW DIRLAM**, age 23 of Honesdale, PA was placed on probation for a period of 12 months for two counts of Possession of Drug Paraphernalia (M) and one count of Possession of Controlled Substance (M). He was also ordered to pay the costs of prosecution, pay a fine in the amount of \$500.00, and comply with all treatment recommendations in accordance with his drug and alcohol assessment. The incident took place on September 9, 2017, in Oregon Township, Wayne County and on October 10, 2017, in Texas Township, Wayne County.

**STEVEN CRAIGIE**, age 34 of Jim Thorpe, PA was sentenced to the Wayne County Correctional Facility for a period of not less than 11 1/2 months nor more than 23 1/2 months for one count of Home Improvement Fraud (M1). He was also ordered to pay the costs of prosecution, pay a fine in the amount of \$500.00, and undergo a drug and alcohol evaluation. The incident occurred on May 1, 2017, in Salem Township, Wayne County.

ALEXANDER CLARK, age 32 of Lake Ariel, PA was placed on probation for a period of 6 months for one count of DUI (M). He was also ordered to pay the costs of prosecution, pay a fine in the amount of \$300.00, participate in and cooperate with the drug and alcohol addiction treatment, complete the Alcohol Highway Safety Program, and perform 50 hours of community service. The incident took place on October 2, 2017, in Lake Township, Wayne County. His BAC revealed a .119%.

**VIRGINA GREESON**, age 45 of Waymart, PA was placed on probation for a period of 6 months for one count of Retail Theft (M2). She was also ordered to pay the costs of prosecution, pay a fine in the amount of \$100.00, undergo a drug and alcohol evaluation, and satisfactorily address her outstanding warrant. The incident took place on December 14, 2017, Waymart Borough, Wayne County.



#### CHILD MOLESTER SENTENCED 12–24 YEARS

July 5, 2018 — Patrick L. Robinson, Wayne County District Attorney announced that Douglas S. Turner, age 48 of Honesdale, PA was sentenced today by Senior Judge Raymond L. Hamill to a State Correctional Institution for a period of not less than 12 years nor more than 24 years for two counts of Involuntary Sexual Deviate Intercourse (F1), one count of Statutory Sexual Assault (F1), one count of Aggravated Indecent Assault (F2), and one count of Indecent Exposure (M1).

First Assistant District Attorney, Deborah Rothenberg, stated "I am pleased that Mr. Turner was designated to be a sexually violent predator because that is what he is. He took advantage of a mentally delayed minor female, who he was over 30 years older than, and he took advantage of her on multiple occasions. Senior Judge Raymond L. Hamilll, was spot on when he pointed out the disparity between the favorable letters written about Mr. Turner by his friends and family, referring to him as a hard working family man, and the charges of which he was convicted. As the Judge indicated, people who sexually offend against children are, in many instances, otherwise upstanding members of society and their friends and families would never know that they are molesting children. That is why child molestation is so terrifying. I am glad this child molester is off of our streets for over a decade and that when he does eventually get out of prison he will be required to register under Megan's Law for the remainder of his lifetime."

District Attorney Robinson stated "The Pennsylvania State Police and Debbie Rothenberg did an outstanding job of investigating this case and preparing the case for a Jury Trial. Given their very hard work, this Defendant had little choice but to enter a Guilty Plea."

#### TEACHER GOES TO JAIL FOR INVASION OF PRIVACY

July 5, 2018 — Patrick L. Robinson, Wayne County District Attorney announced that Gaspare Nicholas Gambino, age 35 of Honesdale, PA was sentenced today by Senior Judge Raymond L. Hamill to the Wayne County Correctional Facility for a period of not less than 180 days nor more than 60 months, less 1 day for six counts of Invasion of Privacy (M2).

Gambino will spend the next 6 months behind bars for surreptitiously taking photographs of students while he was a teacher at Honesdale High School. The photographs were discovered on Gambino's school issued IPad. Six of those photographs depicted the clothed but intimate areas of female students which were not intended to be visible by normal public observation. After careful review of each photograph, it was the

legal conclusion of the District Attorney's Office that the six photographs to which Gambino pled guilty met the legal definition of Invasion of Privacy. Gambino is now a Megan's Law Offender and for the next fifteen years will be required to annually register his home and work addresses. Prior to the guilty plea, Gambino was fired by the Wayne Highlands School District. As part of the plea, Gambino surrendered his Pennsylvania Department of Education Instructional I Certificate and is now permanently barred from reinstatement or education employment eligibility.

District Attorney Robinson stated "Hightech voyeurs such as Gambino will be prosecuted to the fullest extent of the law. The impact of

someone taking abusive photographs will not be downplayed and will not be tolerated."

Senior Deputy District Attorney, Kathleen Martin, said that "Gambino violated the trust not only of these students, but also of the Wayne Highlands School District and the entire Wayne County community. While technology enhances our ability to educate and works to keep us all more connected, it also requires law enforcement officials to be diligent in the investigation and prosecution of those who choose to violate our children and our trust. Thanks to the efforts of the WHSD and PSP, Gambino is no longer in a position to harm our children."

The Wayne County District Attorney's Office commends the administration of Wayne Highlands School District for their swift response to the discovery of these photographs and to the Pennsylvania State Police for their investigation and the arrest of Gambino. Together we will continue to keep our community safe from predators of all types.


