### 11 YEAR OLD DRIVES — FATHER GETS 7 TO 15 YEARS

October 4, 2018 — Wayne County District Attorney, Patrick L. Robinson, announced today that Sean Hannon, age 49 of Dunmore, PA, was sentenced to 7 to 15 years relating to allowing his eleven (11) year old daughter to drive a vehicle from Covington Township, Lackawanna County to Salem Township, Wayne County. The Jury deliberated approximately one (1) hour before reaching their verdict. District Attorney Robinson personally prosecuted the case.

Evidence at Hannon's Jury trial showed that the Defendant allowed his eleven (11) year old daughter to drive approximately 10 miles from his house on Drinker Turnpike, in Covington Township, Lackawanna County to the intersection of SR 690 and Neville Road in Salem Township, Wayne County. The Defendant's eight (8) year old son was a passenger.

The Defendant directed his daughter's driving which eventually resulted in her

running up under a pine tree. The Defendant's BAC was .228%. The Defendant attempted to extricate the vehicle from the pine tree branches but was prevented from doing so by a Good Samaritan who grabbed the vehicle keys from the ignition. During the ride from Lackawanna County to Wayne County the daughter drove erratically swerving, running a stop sign, and running a vehicle coming from the opposite direction into a ditch.

The Defendant was convicted of all charges consisting of two (2) counts Endangering the Welfare of Children (F3), two (2) counts of DUI (M), two (2) counts of Recklessly Endangering Another Person (M2), the Summary offense of Driving While DUI Suspended and the Summary

offense of Permit Unauthorized Person to Drive.

District Attorney Robinson stated, "The Defendant had a terrible prior record of 16 arrests resulting in numerous convictions including four (4) Felonies. This is the Defendant's 3rd DUI conviction. This present wild episode involving his children is just the latest manifestation of the Defendant's anti-social conduct. He is a menace to society and he richly deserves the 7 to 15 years sentence he received today."

### CRIMINAL CASES

The following cases were addressed by the Honorable <u>Raymond L. Hamill, Senior Judge</u>. Wayne County:

### HONESDALE, PA — October 4, 2018

JAY HALL, age 32 of Chippewa Lake, OH was sentenced to a State Correctional Institution for a period of not less than 28 months nor more than 120 months for two counts of DUI (M1). He was also ordered to pay the costs of prosecution, pay a fine in the amount of \$4,000.00, complete the Alcohol Highway Safety Course, and participate in and cooperate with the drug and alcohol addiction treatment. The incidents occurred on October 1, 2016 and October 13, 2016, in Cherry Ridge Township and Honesdale Borough, Wayne County. His blood test on both incidents revealed controlled Substance.

CHRISTOPHER BROWNELL, age 29 of Honesdale, PA was sentenced to the Wayne County Correctional Facility for a period of not less than 4 months nor more than 18 months for one count of Possession of Controlled Substance (M), one count of Possession of drug Paraphernalia (M), one count of Illegally Operating Vehicle without Ignition Interlock (M), and 5 summary offenses related to traffic offenses. He was also ordered to pay the costs of prosecution, pay a total amount of \$\$1,175.00 in fines, undergo a drug and alcohol evaluation, and maintain employment. The incident occurred on October 21, 2017, in Paupack Township, Wayne County.

MICHAEL TESSEYMAN, age 23 of Tyler Hill, PA was sentenced to the Wayne County Correctional Facility for a period of not less than 2 days nor more than 6 months for one count of DUI (M). He was also ordered to pay the costs of prosecution, pay a fine in the amount of \$800.00, participate in and cooperate with the drug and alcohol addiction treatment, and complete the Alcohol Highway Safety Course. The incident occurred on December 7, 2017, in Damascus Township, Wayne County. His BAC revealed a .123%.

CURTIS MAEHL, age 36 of Hawley, PA was sentenced to the Wayne County Correctional Facility for a period of not less than 72 hours nor more than 6 months for one count of DUI (M). He was also ordered to pay the costs of prosecution, participate in and cooperate with the drug and alcohol addiction treatment, and complete the Alcohol Highway Safety Course. The incident occurred on January 20, 2018 in Clinton Township, Wayne County. His BAC revealed a .25%.

KELLY WIETRY, age 26 of Gouldsboro, PA was sentenced to the Wayne County Correctional Facility for a period of not less than 9 months nor more than 36 months for one count of Delivery of Controlled Substance (F) and one count of Criminal Use of Communication Facility (F3). She was also ordered to pay the costs of prosecution, pay a fine in the amount of \$500.00, undergo a drug and alcohol evaluation, comply with

mental health treatment, and obtain employment. The incident occurred on October 23-27, 2017 in Lehigh Township, Wayne County.

MELISSA RODRIGUEZ, age 32 of Hackettstown, NJ was sentenced to the Wayne County Correctional Facility for a period of not less than 11 days nor more than 18 months for one count of Simple Assault (M2). She was also ordered to pay the costs of prosecution, complete an anger management course, continue with mental health, and refrain from contact with the victim. The incident occurred on February 12, 2018, in Lehigh Township, Wayne County.

JOSEPH FELICETTA, age 20 of Honesdale, PA was placed on probation for a period of not less than 6 months for one count of Possession of Drug Paraphernalia (M). He was also ordered to pay the costs of prosecution, pay a fine in the amount of \$300.00, undergo a drug and alcohol evaluation, perform 50 hours of community service, and obtain employment. The incident occurred on April 14, 2018, in Bethany Borough, Wayne County.

CAITLIN BURKHEAD, age 25 of Honesdale, PA was placed on probation for a period of not less than 24 months for one count of Criminal Conspiracy-Theft by Unlawful Taking (M1) and one count of Receiving Stolen Property (M1) She was also ordered to pay the costs of prosecution, pay restitution the amount of \$400.00, and continue drug and alcohol treatment. The incidents occurred on March 26, 2018 in Honesdale Borough and April 19, 2018, in Dyberry Township, Wayne County.

DAVID BUTLER, age 38 of Sterling, PA was sentenced to the Wayne County Correctional Facility for a period of not less than 90 days followed immediately by 60 months less 90 days in the Intermediate Punishment Program. He was also ordered to pay the costs of prosecution, pay fines in the total amount of \$4,000.00, be placed on House Arrest with Electronic and Alcohol Monitoring for a period of 9 months upon parole, participate in and cooperate with the drug and alcohol addiction treatment, perform 100 hours of community service, complete the Alcohol Highway Safety Program, and maintain employment. The incident occurred on November 22, 2017 and April 27, 2018 in Sterling Township, Wayne County. His BAC tests revealed .195% and .239%.


