#### DRUGS FOUND AS RESULT OF TERRORISTIC THREATS

December 14, 2018 — The Honesdale Borough Police Chief Richard Southerton and Wayne County District Attorney Patrick L. Robinson announced a major arrest last night for Drug Dealing activity in Honesdale upon a report of a male threatening persons with a gun.

Pierre Schandall, age 27, was arrested and charged with Possession with the Intent to Deliver Controlled Substance (F), Possession of Controlled Substance (M), Simple Assault (M2), Recklessly Endangering Another Person (M2), Terroristic Threats (M1), Possessing Instruments of Crime (M1), Disorderly Conduct (M3), Possession of Drug Paraphernalia (M3), and Possession of Small Amount of Marijuana (M3).

According to the Affidavit of Probable Cause filed by Ptlm. David Clark, the Honesdale Borough Police, Ptlm. Keith Rynearson and Ptlm. David Clark were dispatched to a disturbance outside of 1037 Main Street. Upon arriving at the residence, it was determined that Schandall had gotten into a disagreement with his neighbors and during the course of the argument brandished a gun in an attempt to terrorize them.

When the police spoke with Schandall in his apartment they detected an overwhelming odor of burnt marijuana and observed drug paraphernalia in plain view. Consent to search the apartment was obtained where a black pellet gun and a small safe was found. There was a strong odor of marijuana coming from the safe. As a result, the safe was seized and search warrant was later obtained. Upon executing the search warrant the following items were found:

- \$10,800.00 in cash
- · A large amount of marijuana
- · Hallucinogenic mushrooms
- · Numerous scheduled drugs
- Numerous items of drug paraphernalia



District Attorney Robinson stated, "This is another example of excellent police work by the Honesdale Borough Police resulting in the seizure of a significant amount of illegal drugs and drug money. Law Enforcement in Wayne County will continue to be vigilant and proactive in an effort to catch

and punish drug dealers to the fullest extent of the law."

Schandall was arraigned in front of MDJ Myers and was remanded to the Wayne County Correctional Facility in lieu of \$25,000 bail. He is scheduled for Central Court on December 19, 2018 at the Wayne County Courthouse.

The filing of criminal charges is not evidence of guilt but simply a description of the charge made by the Commonwealth against a defendant. A charged Defendant is presumed innocent until a jury returns a unanimous finding that the Commonwealth has proven the defendant's guilt beyond a reasonable doubt or until the defendant enters a guilty plea to the charges.

#### CRIMINAL CASES

#### HONESDALE, PA — December 6, 2018

JESSE NIKOLE MCNAMARA age 34 of Hawley, PA was sentenced to the Wayne County Correctional Facility for a period of not less than 6 months nor more than 12 months, for one count of Possession of Controlled Substance-Crystal Meth (M). She was also ordered to pay the costs of prosecution and undergo a drug and alcohol evaluation. The incident occurred on July 2, 2018, in Honesdale Borough, Wayne County.

CRYSTAL CHEREE MAYNOR, age 34 of Gouldsboro, PA was sentenced to the Wayne County Correctional Facility for a period of not less than 89 days nor more than 12 months, for one count of Possession of Controlled Substance-Hydrocodone and Oxycontin (M) and one count of Possession of Drug Paraphernalia (M). She was also ordered to pay the costs of prosecution and undergo a drug and alcohol evaluation. The incident occurred on September 17, 2014, in Lehigh Township, Wayne County.

DYLAN MCARTHUR, age 20 of Prompton, PA was sentenced to the Wayne County Correctional Facility for a period of not less than 6 months nor more than 23 1/2 months, for three counts of Terroristic Threats (M1) and three counts of Simple Assault (M2). He was also ordered to pay the costs of prosecution, comply with the drug and alcohol evaluation treatment recommendations, comply with all mental health evaluation treatment recommendations, complete an anger management course, and obtain employment within 30 days of parole. The incident occurred on March 7, 2018, in Honesdale Borough, Wayne County.

CLYDE ROLLISON age 59 of Lake Ariel, PA was placed in the Intermediate Punishment Program for a total sentence of 12 months, 90 days for two counts of DUI (M) and two counts of Driving While Operating Privileges Suspended/Revoked (S). He was also ordered to pay the costs of prosecution, pay fines in the total amount of \$2,500.00, be placed on House Arrest with Electronic and Alcohol Monitoring for a period of 150 days, and participate in and cooperate with the drug and alcohol addiction

treatment, undergo a mental health evaluation, and complete the Alcohol Highway Safety Program. The incident occurred on May 18, 2018 and September 9, 2016 in Salem and Lake Township, Wayne County. His BAC revealed a .083% and a .234%.

BRYAN ENGVALDSEN, age 46 of Hawley, PA was sentenced to the Wayne County Correctional Facility for a period 30 days followed immediately by 60 months less days in the Intermediate Punishment Program for one count of DUI (M1). He was also ordered to pay the costs of prosecution, pay fines in the total amount of \$1,500.00, be placed on House Arrest with Electronic and Alcohol Monitoring for a period of 90 days, participate in and cooperate with the drug and alcohol addiction treatment, perform 50 hours of community service, and complete the Alcohol Highway Safety Program. The incident occurred on May 19, 2018 Honesdale Borough, Wayne County. His BAC revealed a .230%

SEAN LAWRENCE HERLIHY age 48 of Lake Ariel, PA was placed in the Intermediate Punishment Program for a period of 6 months for one count DUI (M). He was also ordered to pay the costs of prosecution, pay fines in the total amount of \$1,000.00, be placed on House Arrest with Electronic and Alcohol Monitoring for a period of 3 days, participate in and cooperate with the drug and alcohol addiction treatment, complete 25 hours of community service, and complete the Alcohol Highway Safety Program. The incident occurred on March 28, 2018 in Salem Township, Wayne County. He refused chemical testing.

CRYSTAL CHAVEZ age 33 of Scranton, PA was placed in the Intermediate Punishment Program for a period of 6 months for one count DUI (M). She was also ordered to pay the costs of prosecution, pay fines in the total amount of \$1,000.00, be placed on House Arrest with Electronic and Alcohol Monitoring for a period of 3 days, participate in and cooperate with the drug and alcohol addiction treatment, continue mental health treatment, and complete the Alcohol Highway Safety Program. The incident occurred on April 7, 2018 in Honesdale Borough, Wayne County. Her blood test revealed a controlled substance.

MERRITT GARTON, age 66 of Honesdale, PA was sentenced to the Wayne County Correctional Facility for a period of not less than 48 hours nor more than 6 months for one count of DUI (M). He was also ordered to pay the costs of prosecution, pay a fine in the amount of \$500.00, participate in and cooperate with the drug and alcohol addiction treatment, complete the Alcohol Highway Safety Program, and perform 20 hours of community service. The incident occurred on April 4, 2018, in Honesdale Borough, Wayne County. His BAC revealed a .126%.

WALTER LEWIS, age 36 of Deposit, NY was sentenced to the Wayne County Correctional Facility for a period of not less than 11 days nor more than 6 months for one count of DUI (M). He was also ordered to pay the costs of prosecution, pay a fine in the amount of \$1,000.00, participate in and cooperate with the drug and alcohol addiction treatment, and complete the Alcohol Highway Safety Program. The incident occurred on April 4, 2018, in Buckingham Township, Wayne County. His BAC revealed a .193%.

JENNIFER PROCTOR, age 41 of Bangor, PA was placed on probation for a period of 24 months for one count of Criminal Conspiracy-Stalking (M1). She was also ordered to

pay the costs of prosecution, refrain from contact with the victim's, perform 50 hours of community service within 6 months, and continue with ongoing mental health treatment. The incident occurred over a time period from May 22, 2018 to June 3, 2018, in Honesdale Borough, Wayne County.

BRADLEY COMMEAU, age 41 of Honesdale, PA, was placed on probation for a period of 18 months for one count of Possession of a Controlled Substance with Intent to Deliver-Marijuana (M). He was also ordered to pay the costs of prosecution, pay a fine in the amount of \$1,000.00, comply with all recommendations of your drug and alcohol assessment, submit to the drawing of a DNA sample and pay \$250.00 for the cost, and maintain employment. The incident occurred on April 23, 2018, in Honesdale Borough, Wayne County.

CODY KIZER, age 27 of Moscow, PA was placed on probation for a period of 12 months for one count of Recklessly Endangering Another Person (M2). He was also ordered to pay the costs of prosecution, undergo a drug and alcohol evaluation, continue with mental health treatment, and obtain employment within 30 days.
