#### SECTION 1 - TITLE

This Ordinance shall be known and may be cited as the Waymart Borough Ordinance accepting the dedication of Water Street as one way going East, entering from Belmont Street at Wayne Bank and ending at East Street and allowing no parking on either side of street.




