RE: Custody/Divorce Matters

Currently, Wayne County utilizes Custody and Divorce Masters for family law matters, including Masters hearing primary custody cases. This practice will be discontinued and primary custody cases requiring a hearing will be heard by a Judge of the Court of Common Pleas. Further, the Court will be utilizing mediation to resolve custody matters. Attorney Pam Wilson recently resigned as Master and the Court has hired Attorney Ashley Zimmerman to replace her. The Court will discontinue using the phrase "Custody/Divorce Master" and use the phrase "Custody/Divorce Hearing Officer" for Attorney Schloesser and Attorney Zimmerman. The Court has also hired Attorney Kathryn Karam as a Custody Conciliator. Other than matters that are currently scheduled for a hearing before a Custody Master, the above changes will be effective **August 9, 2019.**

The new policy will be as follows:

- Upon filing of a custody complaint or a modification, the matter will be scheduled
 for a conciliation conference with Atty. Karam. Atty. Karam will be responsible for
 the initial meeting with participants and her goal will be to assist the parties in
 reaching a mutually agreeable resolution.
 - a. If a resolution is reached, she will assist the parties in placing that agreement on the record. The agreement will be transcribed by Court staff, recommended by Atty. Karam and made an Order of Court.
 - b. If a resolution is not reached, Atty. Karam will complete a Custody Hearing Form. An example of that form is attached to this Memo. On said form, Atty. Karam will indicate whether the parties are seeking primary custody.
 - c. If primary custody is sought, and there is no resolution reached with Atty. Karam, the matter will be scheduled for a pre-trial conference and a trial with a Common Pleas Judge.
 - d. If primary custody is not sought, and there is no resolution reached with Atty. Karam, the matter will be scheduled for a hearing with a Custody Hearing Officer.
- 2. Upon filing of a request for a Divorce Hearing, either Ashley Zimmerman, Esq. or Warren Schloesser, Esq. will be appointed.

I hope to work with the Bar Association in putting this new policy into effect smoothly. Please feel free to reach out to Nicole Hendrix, Court Administrator, with any questions or concerns.


