District Attorney's Office — Press Release

SHERIFF'S K-9 ASSISTS IN DRUG ARREST

September 10, 2019 — Patrick L. Robinson, Wayne County District Attorney, announced today the arrest of Jeffrey Robert Drumm, age 36, formerly of Lakewood, Pennsylvania. Drumm was charged with Possession of a Controlled Substance (Misdemeanor) and Contempt for Violation of Order or Agreement.

According to the Affidavit of Probable Cause filed by Sergeant Donald Thacher of the Honesdale Borough Police Department, on September 9, 2019 at approximately 9:22 am, Sergeant Thacher observed a vehicle being driven by Drumm on Court Street near 8th Street in Honesdale Borough that displayed an expired inspection sticker. Wayne County Deputy Sheriff Kominski and his partner, K-9 Manfred, arrived shortly thereafter. As the traffic stop concluded, Sergeant Thacher asked Drumm for permission to have the K-9 search his vehicle and Drumm agreed. The K-9 alerted to the passenger side of the vehicle, indicating the presence of a controlled substance inside. A search of the vehicle was conducted by Wayne County Deputy Sheriff Sanservino, who found one small package containing two grams of suspected methamphetamine and two small packages containing suspected methamphetamine residue. The officers also discovered that there was an active Protection from Abuse order prohibiting Jeffrey Robert Drumm from having contact with his passenger.

Drumm was taken into custody for the suspected methamphetamine and for violating the Protection from Abuse order. He was brought before Magisterial District Judge Carney for a Preliminary Arraignment. He was arraigned and released on \$10,000.00 unsecured bail for Possession of a Controlled Substance (methamphetamine) with a Central Court date set for September 18, 2019 at 9:00 am. Subsequently, Drumm was remanded to the Wayne County Correctional Facility after failing to post the \$2,000.00 bail set for the charge relating to Contempt for Violation of Order or Agreement. A court date for that charge will be set at a later time.

District Attorney Robinson stated, "This is a small example of the value of K-9 Manfred in detecting illegal drugs. This stop also serves as a warning to the citizens of Wayne County that methamphetamine is a looming problem. Methamphetamine is evil and must be stopped before it becomes an epidemic."

^{*}The filing of criminal charges is not evidence of guilt but simply a description of the charge made by the Commonwealth against a defendant. A charged Defendant is presumed innocent until a jury returns a unanimous finding that the Commonwealth has proven the defendant's guilt beyond a reasonable doubt or until the defendant enters a guilty plea to the charges.

CRIMINAL CASES

ALEXANDER DEGROAT, age 24 of Hawley, PA was placed in the Intermediate Punishment Program for a period of 6 months for one count of DUI: Controlled Substance/Combine Alcohol (M). He was also ordered to pay the costs of prosecution and pay a fine in the amount of \$1,000.00. Be placed on House Arrest with Electronic Monitoring through the SCRAM program for a period of 72 hours, participate in and cooperate with the drug and alcohol addiction treatment, and complete the Alcohol Highway Safety Program. The incident occurred on June 8, 2018 in Canaan Township, Wayne County, His Blood test revealed a BAC of .146% plus Marijuana.

JACOB FLIS, age 27 of West Pittston, PA was sentenced to the Wayne County Correctional Facility for a period of not less than 5 days nor more than 6 months for one count of Resisting Arrest (M2) and one count of DUI (M). He was also ordered to pay the costs of prosecution, pay a fine in the amount of \$600.00, and pay restitution in the amount of \$250.00. Participate in and cooperate with drug and alcohol addiction treatment, complete the Alcohol Highway Safety Program, and continue mental health treatment and comply with any recommendations for treatment. The incident occurred on May 26, 2018 in Dyberry Township, Wayne County. His blood test revealed a BAC of .223% plus drugs.

ROBERT GREEN, age 29 of Williamstown, NJ, was sentenced to the Wayne County Correctional Facility for a period of not less than 4 months nor more than 23 1/2 months for one count of Unauthorized Use of Automobile and Other Vehicles (M2). He was also ordered to pay the costs of prosecution, pay restitution in the amount of \$6,800.00, undergo a drug and alcohol evaluation and comply with any recommendation for treatment. The incident occurred on September 1, 2017 in Dreher Township, Wayne County.

MICHAEL GREINER, age 36 of Lake Ariel, PA was sentenced to the Wayne County Correctional Facility for a period of not less than 1 month nor more than 18 months for one count of Simple Assault (M2). He was also ordered to pay the costs of prosecution, undergo a drug and alcohol evaluation and comply with any recommendation for treatment, and refrain from having contact with the victim while on parole. Complete anger management program provided by parole officer and obtain employment within 30 days of parole or provide documentation from a doctor precluding you from employment. The incident occurred on November 24, 2018, in Lake Township, Wayne County.

SHANE KNECHT, age 27 of Gouldsboro, PA was sentenced to the State Correctional Institution for a period of not less than 16 months nor more than 84 months consecutive to the Wayne County Information. He was also ordered to pay the costs of prosecution, pay \$250.00 to the DNA detection Fund and pay a fine in the amount of \$300.00 for one

count of Criminal Conspiracy- Delivery of a Controlled Substance (F), and one count of Possession of Controlled Substance- Crystal Methamphetamine (M). The incident occurred on November 15- 22, 2018, in Texas Township, Wayne County.

TERA KOLARCIK, of Hawley, PA, was placed in the Intermediate Punishment Program for a period of 6 months for one count of DUI: Controlled Substance- Impaired Ability (M). She was also ordered to pay the costs of prosecution, and pay a fine in the amount of \$1,000.00. Be placed on House Arrest with Electronic and Alcohol Monitoring through the SCRAM program for a period of 72 hours. Participate in and cooperate with the drug and alcohol addiction treatment, complete the Alcohol Highway Safety Program, undergo a mental health evaluation and comply with all recommendations for treatment. Comply with all Children and Youth Services recommendations and maintain employment or provide documentation from a doctor precluding you from employment. The incident occurred on November 7, 2013 in PaupackTownship, Wayne County. Her blood test revealed a BAC of drugs above legal limit.

ROBERT KRZEMIENIECKI, age 37 of Honesdale, PA was placed on probation for a period of 12 months for one count of Disorderly Conduct (M3). He was also ordered to pay the costs of prosecution, participate in and cooperate with drug and alcohol addiction treatment, undergo mental health evaluation and comply with any recommendations for treatment. The incident occurred on February 2, 2019 in Honesdale borough, Wayne County.

BRIAN SHYLKOFSKI, age 42 of Honesdale, PA was placed on probation for a period of 12 months for one count of Possession of Drug Paraphernalia (M). He was also ordered to pay the costs of prosecution, pay a fine in the amount of \$300.00, undergo a drug and alcohol evaluation and comply with any recommendations for treatment and complete 50 hours of community service. The incident occurred on December 8, 2018 in Cherry Ridge Township, Wayne County.

JOSEPH VOTO, age 32 of Hawley, PA was sentenced to the Wayne County Correctional Facility for a period of not less than 1 months nor more than 6 months for one count of DUI (M). He was also ordered to pay the costs of prosecution, pay a fine in the amount of \$1,000.00, participate in and cooperate with the drug and alcohol addiction treatment, complete the Alcohol Highway Safety Program, and obtain employment within 30 days of parole or provided documentation from doctor precluding you from employment. The incident occurred on December 1, 2018 in Wayne County. His blood test revealed a BAC of .185% plus Oxycodone and Marijuana.

GLENN MINNICK, age 63 of Greentown, PA, was placed on the Accelerated Rehabilitative Disposition Program for a period of 6 months related to DUI. He was also ordered to pay all Court costs and perform 30 hours of community service and have his operator's privileges suspended for 60 days. The incident occurred on February 26, 2019 in Salem Township, Wayne County. His blood test revealed a BAC of .264%.

SAMANTHA PHAM, age 29 of Spring Brook Township, PA, was placed on the Accelerated Rehabilitative Disposition Program for a period of 6 months related to DUI. She was also ordered to pay all Court costs and perform 30 hours of community service

and have her operator's privileges suspended for 60 days. The incident occurred on November 19, 2018 in Hawley Borough, Wayne County. Her blood test revealed a BAC of .181%.

DAVID ROMAS, age 54 of Hawley, PA, was placed on the Accelerated Rehabilitative Disposition Program for a period of 6 months related to DUI. He was also ordered to pay all Court costs and perform 30 hours of community service and have his operator's privileges suspended for 60 days. The incident occurred on February 9, 2019 in Palmyra Township, Wayne County. His blood test revealed a BAC of .214%.

RAMONA SANGSTER, age 25 of Equinunk, PA, was placed on the Accelerated Rehabilitative Disposition Program for a period of 6 months related to Insurance Fraud and Theft by Deception-False Impression. She was also ordered to pay all Court costs and perform 20 hours of community service. The incident occurred on August 5-6, 2018 in Manchester Township, Wayne County.
