# District Attorney's Office — Press Release

#### ROSA-PENA SENTENCED

September 26, 2019 — Patrick L. Robinson, Wayne County District Attorney, announced that Ramon Luis Rosa-Pena (A.K.A. Carlos Perez), age 47, was sentenced to eighteen (18) months to seventy-two (72) months for two (2) counts of Retail Theft and one (1) count of Possession of Drug Paraphernalia. Rosa-Pena had twenty-one (21) previous convictions, predominantly in Wayne County and Philadelphia, mostly for drugs and small-time thefts.

District Attorney Robinson stated, "This Defendant is incorrigible. He has been a constant drain on the time and resources of Wayne County law enforcement. Enough is enough! The State Penitentiary is the appropriate residence for Mr. Rosa-Pena."

#### CRIMINAL CASES

The following cases were addressed by the Honorable <u>Janine Edwards, President Judge</u> Wayne County:

#### HONESDALE, PA — August 29, 2019

DONALD CLARK, age 56 of Paterson, NJ, was sentenced to the Wayne County Correctional Facility for a period of not less than 24 months nor more than 60 months (less one day) for one count of Criminal Attempt- Criminal Trespass (F2). He was also ordered to pay the costs of prosecution, pay \$250.00 to the DNA Detection Fund, pay restitution in the amount of \$225.00, and continue mental health treatment and comply with any and all recommendations. The incident occurred on February 19, 2018 in Clinton Township, Wayne County.

KYLE MICHAELS, age 24 of Pleasant Mount, PA was sentenced to the Wayne County Correctional Facility for a period of not less than 1 months nor more than 11 1/2 months for one count of Simple Assault (M1) and one count of Endangering Welfare of Children as Parent/Guardian (M1). He was also ordered to pay the costs of

prosecution, undergo a mental health evaluation and comply with all recommendation, attend and complete an anger management course, and complete parenting classes provided by your parole officer. The incident occurred on January 11, 2019 in Pleasant Mount Township, Wayne County.

JASMINE MUCKLE, age 21 of Lake Ariel, PA, was placed in the Wayne County Correctional Facility for a period of not less than 3 months and 72 hours nor more than 42 months for one count of DUI (M) and one count of Criminal Conspiracy- Delivery of a Controlled Substance-Crystal Methamphetamine (F). She was also ordered to pay the costs of prosecution, pay a fine in the amount of \$1,000.00, pay restitution in the amount of \$59.13, participate in and cooperates with the drug and alcohol addiction treatment, participate and cooperate with mental health treatment diagnosed by Doctor Burger. Pay \$250.00 to the DNA Detection fund, perform 30 hours of community service within 3 months of parole and obtain employment within 30 days of parole, referred to the Work Force Alliance program. The incident occurred on August 12, 2018 in Paupack Township, Wayne County. His blood test revealed a BAC of .106%.

CARL MERCHANT, age 53 of Honesdale Pa, was sentenced to pay a fine in the amount of \$25.00 for one count of Retail Theft (S). He was also order to pay the costs of prosecution. The incident occurred on October 27, 2018 in Texas Township, Wayne County.

JACQUELYN CUNNINGHAM, age 44 of Oxon Hill, MD was placed on the Accelerated Rehabilitative Disposition Program for a period of 6 months related to DUI. She was also ordered to pay all Court costs and perform 20 hours of community service and have her operator's privileges suspended for 30 days. The incident occurred on March 3, 2019 in Paupack Township, Wayne County. Her blood test revealed a BAC of .105%.

KYLEE DANIELS, age 20 of St Joseph, MD was placed on the Accelerated Rehabilitative Disposition Program for a period of 6 months related to DUI. She was also ordered to pay all Court costs and perform 20 hours of community service and have her operator's privileges suspended for 90 days. The incident occurred on July 13, 2018 in Buckingham Township, Wayne County. Her blood test revealed a BAC of .135%.

ANTHONY LAGATTUTA, age 21 of Honesdale, PA, was placed on the Accelerated Rehabilitative Disposition Program for a period of 6 months related to DUI. He was also ordered to pay all Court costs and perform 25 hours of community service and have his operator's privileges suspended for 60 days. The incident occurred on March 7, 2019 in Cherry Ridge Township, Wayne County. His blood test revealed a BAC of drugs.

ZACHARY ROCKEFELLER, age 19 of Lake Ariel, PA, was placed on the Accelerated Rehabilitative Disposition Program for a period of 6 months related to DUI. He was also ordered to pay all Court costs and perform 20 hours of community service and have his operator's privileges suspended for 60 days. The incident occurred on April 20, 2019 in Salem Township, Wayne County. His blood test revealed a BAC of Marijuana.

KIMBERLY VEGH, age 50 of Lake Ariel, Pa, was placed on the Accelerated Rehabilitative Disposition Program for a period of 12 months related to DUI. She was also ordered to pay all Court costs and perform 25 hours of community service and have her operator's privileges suspended for 60 days. The incident occurred on November 20, 2018 in Paupack Township, Wayne County. Her blood test revealed a BAC .037% plus Opiates.

#### HONESDALE, PA — September 5, 2019

JOHN BAND, of Waymart, PA was sentenced to the Wayne County Correctional Facility for a period of not less than 45 days nor more than 60 months for one count of DUI (M1). He was also order to pay the costs of prosecution, be placed on house arrest with electronic and alcohol monitoring through the SCRAM program for a period of 90 days, pay a fine in the amount of \$1,500.00. Participate and cooperate with drug and alcohol treatment, attend and complete the Alcohol Highway Safety Program, complete 50 hours of community service within 12 months and attend and complete the Maze Program.
