The following cases were addressed by the Honorable <u>Janine Edwards</u>, <u>President Judge</u> Wayne County:

#### HONESDALE, PA – October 10, 2019

DAVID ALECKNA, age 23 of Lake Ariel, PA, was placed in the Intermediate Punishment Program for a period of 6 months as a level 3 offender for one count of DUI – Alcohol/Schedule 1 Controlled Substance (M). He was also ordered to pay the costs of prosecution and pay a fine in the amount of \$1,000.00. He was placed on house arrest with Electronic and Alcohol Monitoring through the SCRAM Program for a period of 72 hours, participate in and cooperate with drug and alcohol addiction treatment, attend and complete the Alcohol Highway Safety Program, complete 20 hours of community service within 6 months and attend and complete a GED program during your period on probation. The incident occurred on February 27, 2019 in Salem Township, Wayne County.

LAWRENCE CAMERON, age 57 of Hawley, PA, was placed on probation for a period of 6 months for one count of DUI (M). He was also ordered to pay the costs of prosecution and pay a fine in the amount of \$300.00. He was placed on alcohol monitoring through the SCRAM Program for a period of 60 days, participate in and cooperate with drug and alcohol addiction treatment, attend and complete the Alcohol Highway Safety Program, and attend a minimum of two AA/NA meeting per week. The incident occurred on June 6, 2019 in Cherry Ridge Township, Wayne County.

JUSTIN DELEA, AGE 40 OF Lake Ariel, PA, was sentenced to the Wayne County Correctional Facility for a period of 72 hours, followed immediately by 6 months less 72 hours in the Intermediate Punishment Program as a level 3 offender of one count of DUI (M1). He was also order to pay the costs of prosecution and pay a fine in the amount of \$1,500.00. He was placed on House Arrest with Electronic Monitoring through the SCRAM Program for a period of 90 days, participate in and cooperate with drug and alcohol addiction treatment, and attend and complete the Alcohol Highway Safety Program. The incident occurred on January 19, 2018 in Paupack Township, Wayne County.

YANA GUITSON, age 22 of Mountain Top, PA, was placed in the Intermediate Punishment Program for a period of 6 months for one count of Driving Under Influence of Alcohol – Highest Rate (M). He was also order to pay the costs of prosecution, and pay a fine in the amount of \$1,000.00. Participate in and cooperate with the drug and alcohol addiction treatment, undergo a mental health evaluation and comply with all recommendations for treatment, and attend and complete the Alcohol Highway Safety Program. The incident occurred on December 23, 2018 in Texas Township, Wayne County.

HANNAH KLIOKIS, age 23 of Parkesburg, PA was placed on probation for a period of 6 months for one count of Possession of a Controlled Substance (M). She was also ordered to pay the costs of prosecution, and pay a fine in the amount of \$300.00. Continue mental health treatment and comply with any recommendations for treatment. The incident occurred on December 27, 2018 in Dreher Township, Wayne County.

PEARL TOMCZYK, age 55 of Lake Ariel, PA, was placed on probation for a period of 6 months for one count of Retail Theft – Take Merchandise (M2). She was also order to pay the costs of prosecution, pay a fine in the amount of \$300.00, and pay restitution in the amount of \$24.33 to be paid within one month of sentencing.
