COUNTY DETECTIVES ARREST STEVEN ALBRECHT


December 18, 2019 — Wayne County District Attorney Patrick L. Robinson announced today the arrest of STEVEN ALBRECHT, age 56, originally of Lake Ariel. ALBRECHT is charged with ten (10) counts of Possession of Child Pornography, each count graded as a felony 3rd degree.

According to the Affidavit of Probable Cause filed by the Wayne County Detectives, on September 19, 2019, members of the Pennsylvania State Police Northeast Computer Crime Unit along with law enforcement officers from the Wayne County Sheriff's Department and Wayne County Detectives served a search warrant at Albrecht's residence at the time, 3257 Northgate Road in The Hideout, Lake Ariel, Pennsylvania, after the Wayne County Detectives received a cyber tip from the National Center for Missing and Exploited Children.

During the search of Albrecht's residence, Wayne County Detectives and Sheriff Deputies seized multiple electronic devices that were reviewed by the Pennsylvania State Police Computer Crime Unit. As a result of the search, Albrecht was found to be in possession of multiple images containing child pornography on his computer.

Albrecht was arraigned by Magisterial District Judge Ronald Edwards today and was released on bail. His next court date is scheduled for January 8, 2020 at 9:00 am.

The filing of criminal charges is not evidence of guilt but simply a description of the charge made by the Commonwealth against a defendant. A charged Defendant is presumed innocent until a jury returns a unanimous finding that the Commonwealth has proven the defendant's guilt beyond a reasonable doubt or until the defendant enters a guilty plea to the charges.
