### District Attorney's Office — Press Release

### TWO ARRESTED FOR INFANT HOMICIDE

July 9, 2020 — The Wayne County District Attorney announced the arrest of Wayne A. Tompkins and Emily Ann Mack for the September 25, 2019, homicide of W.T., a 3 month old female. Mack, age 28, was the mother of W.T. Tompkins, age 36, was Mack's boyfriend and father of the child.

The Affidavits of Probable Cause filed by State Trooper Gregory Allen allege that Mack and Tompkins were drug users. The child, W.T., was in the custody and control of Mack and Tompkins during the period immediately prior to the child's death. An autopsy conducted on September 26, 2019, along with a final pathology report, revealed W.T. had

- Multiple contusions/bruises of the torso and extremities.
- Numerous acute and healing fractures at various stages of healing.
- Intradural hemorrhages, vascular congestion, brain edema (brain swelling), and indicators of axonal injury (traumatic brain injury).
- The presence of methamphetamine and cocaine.

The Pathologist, Dr. Rameen Starling-Roney, ruled that the cause of death was multiple injuries, methamphetamine toxicity and cocaine exposure. Dr. Starling-Roney ruled the manner of death to be Homicide.

In addition, when the Pennsylvania State Police executed a search warrant of the Mack/Tompkins residence directly following the infant's death they found numerous items of illegal drugs and paraphernalia, some of which were laying around the house within reach of their 2 year old son. On September 30, 2019, both Mack and Tompkins were charged with Endangering the Welfare of Children, a third (3rd) degree felony. Wayne County CYS took custody of the 2 year old child. Both Mack (Oct. 13, 2019) and Tompkins (Oct. 8, 2019) posted bail after the filing of those charges and have remained at large during the death investigation of their infant child.

On July 7, 2020, Mack and Tompkins were apprehended in Bensalem Township. On July 9, 2020, Magisterial District Judge Linus Myers did not set bail.

The Central Court date is set for July 15, 2020.

District Attorney Howell stated "The Pennsylvania State Police's extensive investigation led them to file charges against Mr. Tompkins and Ms. Mack because they allegedly caused the death of W.T. by injuring W.T. and exposing her to drugs. We will continue to investigate claims of child abuse, and when justified, prosecute those responsible for injuring a young child, and in this case, charged with killing a baby girl."

<sup>\*</sup>The filing of criminal charges is not evidence of guilt but simply a description of the charge made by the Commonwealth against a defendant. A charged Defendant is presumed innocent until a jury returns a unanimous finding that the Commonwealth has proven the defendant's guilt beyond a reasonable doubt or until the defendant enters a guilty plea to the charges.

### CONEIL "MURDA" MOORE SENTENCED IN STOMPING MURDER

July 9, 2020 — Wayne County District Attorney A.G. Howell announced the sentencing of Coneil Moore aka "Murda" in the stomping murder of Joseph Keith Stengline.

Senior Judge Kenneth W. Seamans sentenced Moore, age 33, to 11.5 – 24 years in a State Correctional Institution. Mr. Moore previously pled guilty to 3rd degree Murder (F1). Mr. Moore also waived all post sentence right, appellate rights, and post-conviction relief acts rights.

On December 8, 2017, Joseph Keith Stengline, Sr., age 62, was beaten and stomped to death by the five individuals who entered his home to rob and assault the home's

occupants. The items sought to be stolen were drugs and cash. The five (5) Defendants travelled from Monroe County to Gouldsboro to commit the robbery. The elder Stengline was kicked and stomped repeatedly, causing a skull fracture and subdural hematoma. He died five (5) days later in the hospital.

Moore's fellow conspirators were previously sentenced as follows:

Darian Jemal "Smoove" Daniels, age 26, of Monroe County, pleaded Nolo Contendere to Third Degree Murder (F1) on November 15, 2019. Senior Judge Raymond L. Hamill sentenced Daniels to 12 years to 24 years in a State Correctional Institution.

Lewis "Ricky" Tucker, Jr., age 28, of Monroe County pleaded Nolo Contendere to Third Degree Murder (F1) on November 13, 2019. Senior Judge Raymond L. Hamill sentenced Tucker to 15 years to 30 years in a State

Correctional Institution.

Kevin "Kas" Jordan, age 22, of Monroe County pleaded guilty to Third Degree Murder (F1) on February 14, 2019. Senior Judge Raymond L. Hamill sentenced Jordan to 12 years to 24 years in a State Correctional Institution.

Steven "Creez" Cooper, age 20, of Monroe County plead guilty to Criminal Conspiracy – Robbery with Serious Bodily Injury to Another (F1) on February 20, 2020. Senior Judge Kenneth W. Seamans sentenced Cooper on April 7, 2020 to 4 to 8 years in a State Correctional Institution.

District Attorney Howell stated he was thankful that this tragic incident has finally been brought to a legal conclusion. "Over two and a half (2 1/2) years ago Joseph Stengline, Sr, was the victim of a savage and senseless attack by a gang of robbers who arrived in Wayne County to steal drugs and cash generated by drug sales. Despite the blame shifting and total lack of credibility of the Defendants that complicated and delayed the investigation, the cooperative efforts of the Wayne County Detectives, Pennsylvania State Police, Lehigh Township Police, Pocono Mountain Regional Police, the United States Marshalls, and the Federal Bureau of Investigations has finally brought some measure of justice to the Stengline family. This case is an example of the dangers and far reaching impact of illegal drug dealing. Law Enforcement in Wayne County will continue to root out and prosecute the dealers and users of poison in Wayne County."

### **CRIMINAL CASES**

Wayne County District Attorney A.G. Howell announces the following cases addressed by the Honorable Janine Edwards, President Judge Wayne County Court:

### HONESDALE, PA — July 2, 2020

JEREMIAH GUTHRIE, age 51 of Honesdale, Pa was sentenced to the State Correctional Institution for a period of not less than 36 months nor more than 84 months for one count of Terroristic Threats (F3). He was also ordered to pay the costs of prosecution. The incident occurred on December 26, 2019 in the Honesdale Borough when Mr. Guthrie called in a bomb threat to the Wayne County Courthouse. District Attorney A.G. Howell stated, "The Honesdale Borough Police, the Wayne County Sheriff's Department, the Wayne County Probation Department, and the Wayne County Detectives did an excellent job in bringing this matter to a swift and successful conclusion."

MICHAEL DORAN, age 34 of Gouldsboro, Pa was sentenced to the Wayne County Correctional Facility for a period of not less than 9 months nor more than 23 1/2 months for one count of Simple Assault (M2). He was also ordered to pay the costs of prosecution, pay restitution in the amount of \$1,640.00, undergo a drug and alcohol evaluation and comply with any recommendations for treatment, and undergo a mental health evaluation and comply with all recommendations for treatment. The incident occurred on December 25, 2019 in Lehigh Township, Wayne County.

BRIANNA MYRICK, age 23 of Honesdale, Pa was placed on probation for a period of 6 months for one count of Driving Under the Influence of Alcohol (M). She was also ordered to pay the costs of prosecution, be placed on House Arrest with Electronic and Alcohol Monitoring through the SCRAM Program for a period of 72 hours, pay a fine in the amount of \$1,000.00, and participate and cooperate with the drug and alcohol addiction treatment in accordance with her drug and alcohol assessment. The incident occurred on December 8, 2019 in the Honesdale Borough.

WILLIAM TEEPLE, age 33 of Equinunk, Pa was sentenced to the Wayne County Correctional Facility for a period of not less than 10 days nor more than 6 months for one count of DUI (M). He was also ordered to pay the costs of prosecution, be placed on House Arrest with Electronic and Alcohol Monitoring through the SCRAM Program for a period of 20 days, pay a fine in the amount of \$750.00, and participate in and cooperate with the drug and alcohol addiction treatment in accordance with his drug and alcohol assessment. The incident occurred on May 5, 2019 in the Honesdale Borough.

KELIA MASON, age 26 of Hancock, NY was admitted into the ARD program for 6 months for one count of DUI (M). The incident occurred on October 4, 2019 in Buckingham Township, Wayne County.
