DISTRICT ATTORNEY'S OFFICE — PRESS RELEASE

July 17, 2020 — The Wayne County District Attorney's Office was made aware of allegations of Official Oppression, 18 Pa. C.S.A. § 5301, against Mr. Joseph Adams. The statute defining official oppression states:

A person acting or purporting to act in an official capacity or taking advantage of such actual or purported capacity commits a misdemeanor of the second degree if, knowing that his conduct is illegal, he:

- subjects another to arrest, detention, search, seizure, mistreatment, dispossession, assessment, lien or other infringement of personal or property rights; or
- denies or impedes another in the exercise or enjoyment of any right, privilege, power or immunity.

After an investigation by the Wayne County Detectives, it has been determined that there was no violation of either the official oppression statute or any other Pennsylvania criminal statute. It was determined that Mr. Adams did not make demands upon the news media or use his position to influence the news media. It appeared the actions of Mr. Adams were out of a genuine concern for the safety of the people and property of the community and the final decision to remove a story was made by the news media.

This office has declined to take any further action.

^{*}The investigation of criminal charges is not evidence of guilt but simply a description of the allegations made against a person. A person is presumed innocent until a jury returns a unanimous finding that the Commonwealth has proven a person's guilt beyond a reasonable doubt or until a person enters a guilty plea to the charge(s).
