The Wayne County Commissioners adopted Ordinance No. 20-8-20, County Affordable Housing Fees, during their business meeting today. The Ordinance adds an additional \$13.00 to the recording fee for Deeds and Mortgages for the purpose to raise revenues to enable County residents to purchase or rent quality residential housing.

Effective October 1, 2020, the base recording fee will be \$71.75 for Deeds and Mortgages only. No other documents are affected by this.


