CRIMINAL CASES

Wayne County District Attorney A.G. Howell announces the following cases addressed by the Honorable Janine Edwards, President Judge Wayne County Court:

HONESDALE, PA — October 15, 2020

GEORGE HAZIMOF, age 48 of Honesdale Pa, was sentenced to the State Correctional Institute for a total period of not less than 6 years nor more than 12 years for one count of Drug Delivery Resulting in Death- Felony 1. He was also ordered to pay the cost of prosecution and pay restitution in the amount of \$9,151.48. This incident occurred in Honesdale Borough on September 26, 2019, when Jeff Canfield overdosed from drugs sold by the Defendant. Police found Canfield dead in an upstairs bedroom of his residence on September 28, 2019, after a family member notified police that she had not heard from him in two days. Forensic examinations of cellphones possessed by Canfield and the Defendant, with the assistance of Wayne County detectives and other agencies, revealed evidence of drug deals between the two men, including on the afternoon of September 26, 2019, the day police believe Canfield died. An autopsy by Dr. Gary Ross concluded that Canfield died from an overdose of fentanyl, a powerful synthetic opioid drug.

TIMOTHY WILLIAM ADAMS, age 25 of Hawley Pa, was sentenced to 12 months probation and ordered to pay restitution in the amount of \$600.00 for one count of Firearms Not to be Carried Without a License and one count of False Swearing. He was also ordered to pay the cost of prosecution and continue with mental health treatment and follow all recommendations. The incidents occurred on January 28, 2018 and April 25, 2018, in Hawley Borough and Palmyra Township.

CHRISTOPHER KEVIN BREIDENSTEIN, age 37 of Honesdale Pa, was sentenced to 6 months probation, 48 hours house arrest with Electronic and Alcohol Monitoring through the SCRAM program and ordered to pay a fine of \$ 500.00 for one count of Driving Under the Influence of Alcohol. He was also ordered to participate in drug and alcohol treatment in accordance with his assessment, complete the Alcohol Highway Safety Program, and complete 40 hours of community service. This incident occurred on October 26, 2019, in Honesdale Borough.

FRANCESCO ANGELO GIOFFRE, age 19 of Hopatcong NJ, was sentenced to 18 months probation and ordered to pay a fine of \$100.00 for one count of Simple Assault and one count of Possession of Drug Paraphernalia. He was also ordered to pay the cost of prosecution, participate in drug and alcohol treatment in accordance with his assessment, continue mental health treatment and follow all recommendations, and complete an anger management program. The incidents occurred on September 10, 2019 and October 13, 2019, in Texas Township and Honesdale Borough.

THOMAS GRADY, age 54 of Lake Ariel Pa, was sentenced 10 days in the Wayne County Correctional Facility, 5 years probation and ordered to pay a fine of \$1,500.00

for one count of Driving Under the Influence of Alcohol. He was also ordered to pay the cost of prosecution, be placed on house arrest for 80 days through the SCRAM program, participate in drug and alcohol treatment, complete the Alcohol Highway Safety Program, and complete 25 hours of community service. This incident occurred in on December 26, 2019, in Hawley Borough.

ERIC SCOTT GRANT, age 20 of Honesdale Pa, was sentenced to 12 months probation with 5 days house arrest through the SCRAM program and ordered to pay a fine of \$300.00 for one count of Obstructing Law Enforcement, one count of Possession of a Controlled Substance and one count of Purchase, Consumption, Possession or Transport of Alcohol by a person less the 21 years of age. He was also ordered to pay the cost of prosecution, participate in drug and alcohol treatment in accordance to his assessment, and undergo a mental health evaluation and comply with all recommendations. This incident occurred on May 22, 2020, in Honesdale Borough.

CHARLES ROBERT TERRY, age 44 of Tobyhanna Pa, was sentenced to a period of not less than 9 months nor more than 60 months in the Wayne County Correctional Facility for one count of Driving Under the Influence of Alcohol and one count of Driving While Operating Privilege is Suspended/Revoked. He was also ordered to pay a fine of \$3,500.00, pay the cost of prosecution, complete 100 hours of community service, participate in drug and alcohol treatment, and complete the Alcohol Highway Safety program. This incident occurred on July 5, 2019, in Dreher Township.
