Wayne County District Attorney A.G. Howell announces the following cases addressed by the Honorable Janine Edwards, President Judge Wayne County Court:

HONESDALE, PA - October 22, 2020

RYAN MATTHEW BROWN, age 24 of Hawley Pa, was sentenced to a period of not less than 1 month nor more than 18 months in the Wayne County Correctional Facility for one count of Simple Assault. He was also ordered to pay the cost of prosecution, undergo a drug and alcohol evaluation and follow all recommended treatment, continue with mental health treatment, and complete an anger management program. This incident occurred on February 29, 2020 in Cherry Ridge Township.

MICHAEL CLEMO, age 42 of Honesdale Pa, was sentenced to 12 months probation and ordered to pay a fine of \$250.00 for one count of Possession of a Controlled Substance. He was also ordered to pay the cost of prosecution, undergo a mental health evaluation and follow all recommended treatment and undergo a drug and alcohol evaluation and follow all recommended treatment. This incident occurred on December 21, 2019, in Honesdale Borough.

CHARISSE DANELLE COLON, age 44 of Hawley Pa, was sentenced to a period of not less than 10 days nor more than 23 1/2 months in the Wayne County Correctional Facility for one count of Terroristic Threats. She was also ordered to pay the cost of prosecution, have no contact with the victim, undergo a mental health evaluation and follow all recommended treatment, and complete an anger management program. This incident occurred on January 17, 2019, in Texas Township.

JOSEPH PETER KREYLING II, age 27 of Hawley Pa, was sentenced to a period of not less than 10 days nor more than 6 months in the Wayne County Correctional Facility and ordered to pay a fine of \$500.00 for one count of Driving Under the Influence of Alcohol. He was also ordered to pay the cost of prosecution, complete the Alcohol Highway Safety Program, and participate in drug and alcohol treatment and follow all recommendations. This incident occurred on December 4, 2019, in Honesdale Borough.

ANGELA MICHELLE LAHR, age 34 of Honesdale Pa, was sentenced to a period of not less that 2 months nor more than 12 months in the Wayne County Correctional Facility and ordered to pay a fine of \$100.00 for one count of Possession of a Controlled Substance. She was also ordered to participate in drug and alcohol treatment and follow all recommendations and continue with mental health treatment. This incident occurred on January 7, 2020, in Waymart Borough.



He was also ordered to pay the cost of prosecution, pay restitution, undergo a drug and alcohol evaluation and follow all recommended treatment, and undergo a mental health evaluation and follow all recommended treatment. This incident occurred on July 16, 2020, in Paupack Township.
