WAYNE COUNTY COMBAT VETERAN SEEKS DISTRICT JUDGE SEAT

Waymart, PA — Michael J. Farley of Clinton Township, Wayne County, announces his candidacy for the position of Magisterial District Judge for District Number 22-03-4.

Farley, 37, an honorably discharged U.S. Army Infantryman of the First Infantry Division, and seasoned attorney at Barna Law of Honesdale, endeavors to fill the role of the Honorable Ronald J. Edwards, who is retiring.



"I intend to campaign tirelessly, to treat my competitors with respect, the Wayne County way, and to live with the decision of the electorate," Farley said.

Born and raised in Wayne County,

in magisterial courts and served as an
adjudicator with the Wayne County

Wayne County District Attorney A.G. Howell announces the following case addressed by the Honorable Janine Edwards, President Judge Wayne County Court:

HONESDALE, PA — November 19, 2020

LINDSAY DADDIO, age 30 of East Stroudsburg Pa, previously sentenced on April 9, 2020 to a period not less than 12 months nor more than 60 months in the Wayne County Correctional Facility, for one count of Criminal Conspiracy - Criminal Use of Communication Facility and one count of Delivery of a Controlled Substance (Heroin), was resentenced to a State Correctional Facility to serve the remainder of her sentence for violating parole. On October 23, 2020 the Defendant tested positive for illegal substances.

MICHAEL ANTHONY MCHUGH, age 23 of Hawley Pa, was sentenced to 9 months probation for one count of Firearms Not to be Carried Without A license. He was also ordered to pay the cost of prosecution, pay a fine of \$300.00, and obtain employment or provide documentation from his doctor precluding him from employment. This incident occurred on February 19, 2020, in Honesdale Borough.

KEVIN MELESKY, age 38 of Humble TX, previously sentenced on April 16, 2020, to a period not less than 6 months nor more than 12 months in the Wayne County Correctional Facility for one of Theft and DUI was issued a Bench Warrant for failure to appear for a Parole Violation Hearing. The Defendant is in violation of a Court Order for failing to comply with his payment agreement, failure to undergo a Mental Health Evaluation as well as failing to complete the Alcohol Highway Safety Program.

ANGELO TERRANOVA, JR, age 21 of Damascus, previously sentenced on June 18, 2020 to a period of not less than 90 days nor more than 18 months in the Wayne County Correctional Facility, for one count of Retail Theft, was resentenced to the Wayne County Correctional facility for the remainder of his sentence for violating parole. On October 21, 2020 the Defendant tested positive for illegal substances.

BRITTANY WORMUTH, age 25 of Honesdale Pa, was issued a Bench Warrant and had her bail revoked for failure to appear for a Bail Revocation Hearing. On October 29, 2020, the Defendant entered a plea of guilty to one count of criminal use of a communication facility, one count of possession of drug paraphernalia, and one count of possession of marijuana. The Defendant was ordered to contact the Wayne County Probation Department within 24 hours of the guilty plea and failed to do so.

COMPLAINT IN QUIET TITLE

AND NOW, comes the Plaintiff, Janet E. Maher, by and through her Attorneys, **Spall, Rydzewski, Anderson, Lalley & Tunis, P.C. by Leatrice A. Anderson, Esquire,** and files the following Action to Quiet Title, whereof the following is a true and correct statement, to wit:

- 1. That the Plaintiff is an adult individual with a principle residence in Langhorne, Pennsylvania.
- 2. The Defendant, Paupackan Lake Shores, Incorporated, was a corporation established in 1959 and remains open.
- 3. The last known address for Defendants is unknown since the deed conveying the property to them did not list an address as it was likely not required in 1960.
- 4. The property equitably owned by Plaintiff, and thoroughly described in deed recorded in record book 469 on page 912, and the subject of the Deed is identified as follows:

Parcel # 12-0-0011-0046 Control # 041580 Lot 24 A Section 3

5. The property described above was purportedly conveyed to

Joseph Ball according to Deed dated July 10, 1987 recorded in Book 469 on page 912. Copy of said deed attached to Complaint filed of record.

- 6. No such deed, however, was ever recorded.
- 7. The reference deed (469/912) made refers back to the deed conveying the property into the developer of the property, Paupackan Lake Shores, Inc. from 1960. Copy of said deed attached to complaint filed of record.

 8. The tax sale completed in 1987 divested Joseph Ball of any and all right, title and interest to the land, but, unfortunately, he didn't have any recorded right, title or interest
- 9. The tax sale from 1987 made no mention of Paupackan Lake Shores, Inc. even though they were the recorded entity with interest. 10. The deed referenced in the tax claim deed referenced the deed where Defendant, Paupackan Lake Shores, Inc. took ownership of the bulk parcel.

in the land.

11. It is believed that the parcel was sold to Joseph Ball, but the deed was never properly recorded. 12. Paupackan Lake Shores, Inc. is a business entity registered to do business in Pennsylvania since 1959, but has no business address registered except "Lakeville, PA". 13. Lester Male was the creator of "Paupackan Lake Shores" in 1962. 14. Lester Male established the Paupackan Lake Association and saw to its incorporation in 1961. 15. Thereafter, Male had decided to sell to Great American Land. This parcel of land was never conveyed

- to Great American Land, presumably because it was "sold" to Joseph Ball even though the deed was never recorded.

 16. Under Great American Land, the lands sold by Lester Male became Paupackan Lake Association. This parcel is subject to the rules and restrictions of Paupackan Lake Association, but was never included in the sale
- sold to Joseph Ball.
 17. Joseph Ball had paid taxes on the property until about 1985.

because it apparently was already

- 18. Thereafter taxes were not paid and the property was exposed for tax sale.
- 19. Defendants' whereabouts are unknown since the only address is listed as "Lakeville, PA" with Pennsylvania Department of State. 20. Plaintiffs purchased the property from tax sale in 1987 and have made all tax payments, undertaken all liability and assumed all right, title and interest to the property.
- 21. Plaintiff have been the assessed owners of the land since 1987 with no other person or entity challenging their use or ownership. 22. The Plaintiff now seeks to extinguish any and all alleged right, title or interest that the Defendants, or their heirs, executors, administrators, successors or assigns and all persons claiming by, through or under him, shall hold, own or claim.
- 23. Effectively, Plaintiff is seeking to cure the title defect of the missing deed in the chain of title.

WHEREFORE, the Plaintiff

prays this Honorable Court to enter:

(a) An Order barring forever the right of the Defendants and their successors, heirs and assigns from asserting any right, title or interest in and to premises; and (b) An Order decreeing the Plaintiff is the owner in fee simple free of any encumbrances of Defendants of the premises herein described.
