District Attorney's Office — Press Release SUBJECT ARRESTED FOR MULTIPLE DRUG SALES

JANUARY 6, 2021 — Wayne County District Attorney A.G. Howell announced today that numerous criminal charges have been filed against Brandy Marienschek, age 35, of Lackawanna County, PA after an undercover investigation was conducted by members of the Wayne County Drug Task Force. Marienschek is charged with three counts of



BRANDY MARIENSCHEK Delivery of a Controlled Substance, all felonies, one count of Possession With Intent to Deliver a Controlled Substance, a felony, three counts of Criminal Use of Communication Facility, all felony 3rd degree, two counts of Endangering Welfare of Children, both misdemeanor 1st degree and three counts of Possess of a Controlled Substance, all misdemeanors.

According to the first criminal complaint affidavit of probable cause filed by Wayne County Detective Bobby Joe Bendersky, Marienschek sold 20 bags of heroin, a schedule 1 controlled substance, to a subject on two separate occasions within Wayne County in late 2020. On the first occasion,

Marienschek had a small child in the vehicle with her. On the second occasion, Marienschek had what appeared to be a juvenile in the vehicle with her.

According to the second criminal complaint affidavit of probable cause filed by Wayne County Chief Detective Peter Hower, Marienschek sold another 20 bags of heroin to a subject within Wayne County during the middle of December 2020. After her arrest, 4 bags of crystal methamphetamine, a schedule 2 controlled substance, were found in her purse and in her vehicle.

Marienschek was arraigned by Magisterial District Judge Myers on December 14, 2020 for the charges filed by Detective Bendersky. Her bail was set at \$100,000.00 and she was remanded to the Wayne County Correctional Facility.

Marienschek was arraigned by Magisterial District Judge Myers on January 6, 2021 for the charges filed by Detective Hower. Her bail was set at \$5,000.00 and she was remanded back to the Wayne County Correctional Facility.

Her next court appearance is scheduled for January 13, 2021 at 9:00 am.

*The filing of criminal charges is not evidence of guilt but simply a description of the charge made by the Commonwealth against a defendant. A charged defendant is presumed innocent until a jury returns a unanimous finding that the Commonwealth has proven the defendant's guilt beyond a reasonable doubt or until the defendant enters a guilty plea to the charges.

Wayne County District Attorney A.G. Howell announces the following case addressed by the Honorable Janine Edwards, President Judge Wayne County Court:

HONESDALE, PA — January 7, 2021

DAVID ALECKNA, age 25 of Lake Ariel Pa, previously sentenced on October 10, 2019 to the Intermediate Punishment Program, for one count of Driving Under the Influence of Alcohol, was resentenced to 6 months probation. He was also ordered pay the cost of prosecution, be placed on house arrest for 72 hours trough the SCRAM Program, pay a fine of \$300.00, participate and cooperate with drug and alcohol addiction treatment in accordance with his assessment, attend and complete the Alcohol Highway Safety Program, complete 20 hours of community service, and obtain his GED, for noncompliance of the Intermediate Punishment Program.

CHRISTINE BASSETT, age 51 of Honesdale Pa, was sentenced to 6 months probation for one count of Unsworn Falsification – Statement Under Penalty (M3), one count of Required Financial Responsibility (S) and one count of Operation of Vehicle Without Official Certificate of Inspection (S). She was also ordered to pay the cost of prosecution, and pay a fine of \$325.00. This incident occurred July 8, 2019 in Salem Township.

HEATHER CHESKY, age 40 of Hawley Pa, was sentenced to 6 months probation for one count of Simple Assault (M3), one count of Disorderly Conduct (S) and one count of Driving While Operating Privilege is Suspended/Revoked (S). She was also ordered to pay the cost of prosecution, pay a fine of \$300.00, have no contact with the victim, continue with her mental health treatment and comply with any recommendations for treatment attend and complete an anger management program, and obtain employment with in 30 days or provide documentation from a doctor precluding her from employment. This incident occurred on October 23, 2019 in Hawley Borough.

JEROME KUDAJSKI age 55 of Covington Township, previously sentenced on May 3, 2018 to a period of not less than 1 month nor more than 23 1/2 months, for one count of Theft by Unlawful Taking or Disposition (M1), was resentenced to undergo incarceration at the Wayne County Correctional Facility for a period of 12 months, the unserved portion of his sentence, for violating parole. The defendant has failed to comply with his payment agreement with probation and has failed to complete drug and alcohol treatment as ordered on May 3, 2018.

JASON CHARLES LAJOIE, age 44 o Archbald Pa, was issued a Bench Warrant for failure to appear for a Parole Violation Hearing. The defendant was previously sentenced on March 23, 2017 to pay cost, fines and restitution for one count of Theft by Unlawful Taking or Disposition.

VINCENT LEVIER, age 48 of Greentown Pa, was sentenced to 12 months probation for one count of Possession of Drug Paraphernalia (M). He was also ordered to pay the costs of prosecution, pay a fine of \$200.00, and undergo a drug and alcohol evaluation and comply with any recommendations for treatment. This incident occurred March 16, 2019 in Dreher Township.

ANDREW JOHN PESELLI, age 31 of Honesdale Pa, was sentenced to undergo incarceration at the Wayne County Correctional Facility for a period of not less than 6 months nor more than 18 months for one count of Recklessly Endangering Another Person (M2), one count of Simple Assault (M2) and one count Driving Under the Influence (M). He was also ordered to pay the cost of prosecution, pay a fine of \$800.00, attend and complete the Alcohol Highway Safety Program, participate in and cooperate with the drug and alcohol addiction treatment in accordance with your drug and alcohol assessment, have no contact with the victims, complete an anger management program, and undergo a mental health evaluation and comply with all recommendations for treatment. This incident occurred November 17, 2019 in Clinton Township.

WAYNE MICHAEL SEELEY, age 22 of Newfoundland Pa, was sentenced to 18 months probation for one count Possession of a Controlled Substance (M), one count Possession of Drug Paraphernalia (M) and one count Institutional Vandalism (M2). He was also ordered to pay the cost of prosecution, pay a fine of

\$100.00, pay restitution, participate and cooperate with the drug and alcohol addiction treatment in accordance with his assessment. These incidents occurred August 17, 2020 in Dreher Township and August 18, 2020 in Texas Township.

ASHLEY FAYE TAFEL, age 28 of Honesdale Pa, was sentenced to 12 months probation for one count of Recklessly Endangering Another Person (M2). She was also ordered to pay the cost of prosecution, pay a fine of \$300.00, and undergo a drug and alcohol evaluation and comply with all recommendations for treatment. This incident occurred August 1, 2018 in Honesdale Borough.


