
MAN ARRESTED FOR SELLING METHAMPHETMAINE

February 10, 2021 — Wayne County District Attorney A.G. Howell today announced the arrest of Christopher D. Serody, Sr., 57, of Greely, PA. Serody is charged with three counts of Delivery of a Controlled Substance, each graded as a felony, three counts of Criminal Use of Communication Facility, each graded as a felony 3rd degree, and three counts of Possession of a Controlled Substance, each graded as a misdemeanor.

According to the affidavit of probable cause filed by Wayne County Detective Bobby Joe Bendersky, the charges are a result of an undercover investigation conducted by the Wayne County Drug Task Force into the sale of crystal methamphetamine within Wayne County. Between late summer and early fall 2020, Serody made three separate sales of crystal methamphetamine to a confidential informant within Wayne County.

Serody was taken into custody and was arraigned by Magisterial District Judge Myers. His bail was set at \$25,000.00 and he was remanded to the Wayne County Correctional Facility. His next court date was today at 11:30 am in central court.

*The filing of criminal charges is not evidence of guilt but simply a description of the charge made by the Commonwealth against a defendant. A charged Defendant is presumed innocent until a jury returns a unanimous finding that the Commonwealth has proven the defendant's guilt beyond a reasonable doubt or until the defendant enters a guilty plea to the charges.

Wayne County District Attorney A.G. Howell announces the following cases were addressed by the Honorable Janine Edwards, President Judge Wayne County Court:

HONESDALE, PA — February 4, 2021

ANTHONY JOSEPH GAJEWSKI, age 20 of Plymouth Pa, was sentenced to undergo incarceration at the Wayne County Correctional Facility for a period of not less than one month nor more than 18 months for one count of Recklessly Endangering Another Person (M2). He was also ordered to pay the cost of prosecution, continue with his mental health treatment, and undergo a drug and alcohol evaluation and comply with all recommendations for treatment. This incident occurred on July 2, 2019, in Honesdale Borough.

TERESA HAWKINS, age 52 if Honesdale Pa, was sentenced to 6 months probation for one count of Driving Under the Influence of Alcohol (M). She was also ordered to pay the cost of prosecution, pay a mandatory minimum fine of \$300.00, pay restitution in the amount of \$37,800.53, participate in and cooperate with the drug and alcohol addiction treatment in accordance with her assessment, complete the Alcohol Highway Safety Program, and undergo a mental health evaluation and comply with any recommendations for treatment. This incident occurred October 25, 2019, in Texas Township.

MICHAEL JAMES MORGAN age 24 of Ansonia CT, was issued a Bench Warrant for failure to appear at his Probation Violation Hearing.

LAWRENCE JAMES MULLALLY, age 31 of Milford Pa, was sentenced to undergo incarceration in the Wayne County Correctional Facility for a period of not less than 30 days nor more than 12 months for one Count of Driving Under the Influence of Alcohol (M) and one count of Possession of Drug Paraphernalia (M). He was also ordered to pay the cost of prosecution, pay a fine in the amount of \$1,000.00, pay restitution in the amount of \$53.46, participate in and cooperate with the drug and alcohol addiction treatment in accordance with his assessment, complete the Alcohol Highway Safety Course, undergo a mental health evaluation and comply with any recommendations for treatment, and attend AA/NA. This incident occurred on March 30, 2020, in Honesdale Borough.

ELIJAH QUINN NEKICH, age 24 of Milford Pa, was sentenced to 6 months probation for two counts of Disorderly Conduct (M3). 
