Wayne County District Attorney A.G. Howell announces the following cases were addressed by the Honorable Janine Edwards, President Judge Wayne County Court:

HONESDALE, PA — February 24, 2021

CHRISTINA DAWN BENEDICT, age 25 of Honesdale Pa, was sentenced to 6 months probation with 72 hours House Arrest through the SCRAM program of one count of Driving Under the Influence of a Controlled Substance - Impaired Ability (M). She was also ordered to pay the cost of prosecution, pay a mandatory minimum fine of \$1,000.00, participate and cooperate with the drug and alcohol addiction treatment in accordance with her assessment, complete the Alcohol Highway Safety Program, undergo a mental health evaluation and comply with all recommendations for treatment and obtain employment within 60 days or provide documentation from a doctor precluding her from employment This incident occurred on March 20, 2020 in Berlin Township.

DANIEL HANRAHAN, age 30 of Hawley Pa, was sentenced to undergo incarceration in the Wayne County Correctional Facility for a period of not less than 6 months and 3 days nor more than 23 1/2 months for one count of Possessing Instrument of Crime (M1), one count of Possession of a Controlled Substance - Heroin (M) and one count of Driving Under the Influence of Alcohol (M). He was also ordered to pay the costs of prosecution, pay restitution in the amount of \$270.00, participate in and cooperate with the drug and alcohol addiction treatment in accordance with his assessment, complete the Alcohol Highway Safety Course, and obtain employment within 30 days or provide documentation from a doctor precluding him from employment. These incidents occurred October 8, 2020 in Paupack Township, June 17, 2020 in Honesdale Borough, and June 25, 2020 in Texas Township.

DANIEL JACOB KREITER, age 38 of Honesdale Pa, was sentenced to undergo incarceration in the Wayne County Correctional Facility for a period of 1 month followed immediately by 84 months probation with 11 months of House Arrest through the SCRAM program for one count of Driving Under the Influence of Alcohol (F3). He was also ordered to pay the cost of prosecution, pay a mandatory minimum fine of \$2,500.00, participate and cooperate with the drug and alcohol addiction treatment in accordance with her drug and alcohol assessment which will be re-assessed yearly, continue with mental health treatment and comply with all recommendations, and obtain employment within 90 days or provide documentation from a doctor precluding him from employment. This incident occurred on April 20, 2020 in Honesdale Borough.

JOHN JOSEPH McHUGH, age 48 of Madison Township Pa, was sentenced to probation for a period of 6 months with 72 hours House Arrest through the SCRAM program for one count of Driving Under the Influence of a Controlled Substance (M). He was also ordered to pay the cost of prosecution, pay a mandatory minimum fine of \$1,000.00, participate and cooperate with the drug and alcohol addiction treatment in accordance with is assessment, and complete the Alcohol Highway Safety Course. This incident occurred on November 25, 2019 in Salem Township.

CHRISTEN ANN WRIGHTER, age 37 of Hancock NY, previously sentenced on October 18, 2018 to 6 months probation, for one count of for one count of Driving Under the Influence of Alcohol (M), was re-sentenced to undergo incarceration in the Wayne County Correctional Facility for a period of not less than 9 days nor more than 6 months. She was also ordered to pay the cost of prosecution, pay a fine of \$300.00, undergo a drug and alcohol evaluation and comply with all recommendations for treatment, complete the Alcohol Highway Safety course, and obtain employment within 30 days or provide documentation from a doctor precluding her from employment


