CRIMINAL CASES

Wayne County District Attorney A.G. Howell announces the following cases were addressed by the Honorable Janine Edwards, President Judge Wayne County Court:

HONESDALE, PA — October 21, 2021

LESLIE ANN ACKER, age 40 of Prompton PA, was placed on the Accelerated Rehabilitation Disposition Program for a period of 6 months related to a DUI. She was also ordered to pay all costs, perform 20 hours of community service, complete the Alcohol Highway Safety Program, undergo a drug and alcohol evaluation and comply with any recommendations for treatment, and have her driving privileges suspended for a period of 60 days. The incident occurred on March 31, 2021 in Texas Township.

THOMAS SCOTT BARTHOLOMEW, age 56 of Alburtis PA, was placed on the Accelerated Rehabilitation Disposition Program for a period of 6 months related to Boating Under the Influence. He was also ordered to pay all costs, have his watercraft operating privileges suspended for a period of 6 months, complete a commission-approved boating safety course, and undergo a drug and alcohol evaluation and comply with any recommendations for treatment. The incident occurred on June 19, 2021 in Paupack Township.

JOHN PETER FLORIO, age 66 of Northampton PA, was sentenced to undergo incarceration in the Wayne County Correctional Facility for a period of not less than 5 days nor more than 12 months for one count of Simple Assault (M2) and one count of Driving Under the Influence (M). He was also ordered to pay the costs of prosecution, pay a mandatory minimum fine of \$2,300.00, participate in and cooperate with the drug and alcohol addiction treatment in accordance with his assessment, complete the Alcohol Highway Safety Program, and complete an anger management course. The incident took place November 24, 2020 in Dyberry Township.

BRANDON ROBERT IRWIN, age 33 of Hawley PA, was sentenced to undergo incarceration in a State Correctional Facility for a period of not less than 9 months nor more than 60 months for one count of Driving Under the Influence – Controlled Substance (M1). He was also ordered to pay the costs of prosecution, pay a mandatory minimum fine of \$1,500.00, participate in and cooperate with the drug and alcohol addiction treatment in accordance with his assessment, and complete the Alcohol Highway Safety Program. The incident occurred on November 6, 2020 in Hawley Borough.

BRIAN MATTHEWS, age 35 of Honesdale PA, was sentenced to undergo incarceration in a State Correctional Facility for a period of not less than 12 months nor more than 60 months for one count of Driving Under the Influence (F3). He was also ordered to pay the costs of prosecution, pay a mandatory minimum fine of

\$2,500.00, and participate in and cooperate with the drug and alcohol addiction treatment in accordance with his assessment. The incident occurred on May 28, 2021 in Honesdale Borough.

CALEB DEAN MEAD, age 22 of Forest City PA, was placed on the Accelerated Rehabilitation Disposition for a period of 6 months related to a DUI. He was also ordered to pay all costs, perform 20 hours of community service, complete the Alcohol Highway Safety Program, undergo a drug and alcohol evaluation and comply with any recommendations for treatment, and have his driving privileges suspended for a period of 30 days. The incident occurred on February 27, 2021 in South Canaan Township.

ANDREA P. RIOS, age 46 of Hawley PA, was placed on the Accelerated Rehabilitation Disposition for a period of 6 months related to a DUI. She was also ordered to pay all costs, perform 20 hours of community service, complete the Alcohol Highway Safety Program, undergo a drug and alcohol evaluation and comply with any recommendations for treatment, and have her driving privileges suspended for a period of 60 days. The incident occurred on December 23, 2020 in Palmyra Township.


