# District Attorney's Office — Press Release

# NEW YORK MAN ARRESTED ON DRUG CHARGES

March 18, 2022 — Wayne County District Attorney A.G. Howell announced today the arrest of Nikolaos Kopoulos, age 23, of Bethpage, NY. He was charged with Possession With Intent to Distribute Controlled Substances, a felony, Possession of Controlled Substances, a misdemeanor, and Possession of Drug Paraphernalia, a misdemeanor.

According to the police criminal complaint affidavit of probable cause filed by the Wayne County Detectives, the charges stem from an incident that took

place on September 4, 2021 at the Elements Music Festival in Buckingham Township, Wayne County, PA. Security officers from the festival encountered Kopoulos after he illegally re-entered the festival after being removed. They searched his bag and found substantial quantities of psilocybin mushrooms, cocaine, ketamine, LSD, alprazolam, methamphetamine, THC and marijuana. The security officers were assisted by Wayne County Constable Banks and Constable Mead.

An arrest warrant was issued for Kopoulos on October 29, 2021. However, he was not found and taken into custody until January 2022 when he was

arrested in Nassau County, NY. He was brought back to Wayne County on February 21, 2022 and was remanded to the Wayne County Correctional Facility on \$25,000 bail. His Central Court appearance was held on March 16, 2022, at which time the Defendant waived his preliminary hearing.

District Attorney A.G. Howell stated that these charges were the efforts of private security, constables and the Wayne County Detectives working together to keep our community safe.

\*The filing of criminal charges is not evidence of guilt but simply a description of the charge made by the Commonwealth against a defendant. A charged Defendant is presumed innocent until a jury returns a unanimous finding that the Commonwealth has proven the defendant's guilt beyond a reasonable doubt or until the defendant enters a guilty plea to the charges.


