# FROM THE DESK OF THE EDITOR

# NEW ADOPTION RULES TO TAKE EFFECT JULY 1, 2022

The Pennsylvania Supreme Court has overhauled the Orphans' Court Rules pertaining to adoption, replacing current O.C. Rules 15.1 - 15.9 with new O.C. Rules 15.1 - 15.22. In doing so, the Court revised the former Rules and added a number of new ones.

### The revised Rules include:

- 15.2 a new Rule that defines various terms used in connection with adoption proceedings.
- 15.3 augments the notice procedures in proceedings to terminate parental rights by focusing on three areas: (1) who is required to receive notices of termination of parental rights (both voluntary and involuntary) and the form of the notice, (2) how the notice is to be provided, and (3) when the notice must be provided.
- 15.4 applies when a county agency is seeking to terminate the parental rights to, or have someone adopt, a child who has been declared dependent by juvenile court; in these cases, the agency is required to file a praecipe in the dependency proceedings when a petition to terminate parental rights or a petition for adoption is filed, when the Court rules on the petition, when any notice of appeal is filed, and when any appeal is decided, so that the juvenile court docket shows the status of the case in Orphans' Court.
- 15.5. a new Rule codifying the one child/one petition requirement. It requires separate petitions to be filed for each child who is the subject of certain proceedings under the Rules (including terminations of parental rights and adoptions).
- 15.6 a new Rule that applies when a petition for termination is filed and no agency (like CYS) is involved. In these cases, this Rule prohibits a Court from granting a petition for termination unless a Report of Intention to Adopt or Petition for Adoption has been filed. This Rule is meant to implement the precedent set by the Court that one parent cannot terminate the parental rights of the other parent without a present plan for the child's adoption, either by a step-parent or someone else (except in cases involving rape or incest).
- 15.7 details the information and exhibits that should be included in Petitions for Voluntary Relinquishment to an agency. This Rule is based on former Rule 15.2 but leaves out 3 averments from former Rule 15.2 (religious affiliations, names of the birth mother's former husbands, except where the birth mother was married at the time of birth or during the year prior, and whether the child was born out of wedlock), adds 3 new ones (counseling services, Contact Agreements, and consents), and requires 3 new exhibits (a consent to transfer custody to the agency, and a verified statements of the providing of the PACA-notice).

- 15.8 details the information and exhibits that should be included in Petitions for Voluntary Relinquishment with respect to a child who has been in the exclusive care of prospective adoptive parents. This Rule is similar in its requirements to new Rule 15.7.
- 15.9 a new Rule that details the information and exhibits that must be included in Petitions to Confirm Consent to Adoption. This Rule implements an alternative procedure whereby parental rights can be voluntarily relinquished through the court's confirmation of a consent to adoption.
- 15.10 details the information and exhibits that must be included in Petitions for Involuntary Termination of Parental Rights. This Rule is similar to prior Rule 15.4, but, like new Rule 15.7, leaves out certain averments required by the old Rule (like religious affiliations) while requiring new ones. The new averments include averments as to standing, whether a claim for paternity has been filed, the date the child was removed from the parent who is the subject of the petition and the date the child was placed with petitioner, information as to why the child was removed from the parent who is the subject of the petition, provision of the PACA-notice, and that the petitioner believes the petition to be in the child's best interests. This Rule also eliminates certain exhibits required by the old Rule while requiring new exhibits, such as a verified statement regarding provision of the PACA-notice, and a signed consent to accept custody.
- 15.11 a new Rule that implements requirements of the Adoption Act that a parent whose parental rights are terminated receive notice of his or her continuing right to provide and update medical, personal, or social history information with the court and the Dept. of Human Services. It directs the Clerk to inform birth parents of their rights post-termination and sets forth the information that should be provided.
- 15.12 a new Rule that implements provisions of the Adoption Act relating to voluntary post-adoption agreements for continuing contact or communication ("Contact Agreements"). It specifies how Contact Agreements are presented to the court, when they are to be presented, and by whom, as well as the information and exhibits that must be included in Petitions to Approve Contact Agreements.
- 15.13 details the information and exhibits that must be included in Petitions for Adoption. This Rule is based on former Rule 15.5, but adds new requirements, including attaching criminal history records and child abuse clearance certificates for each prospective adoptive parent and alleging the existence of any prior court Orders that might impact the ability of the court to grant the petition.
- 15.14 governs registration of foreign adoption decrees, and is nearly identical to former Rule 15.8.
- 15.15 details the information and exhibits that must be included in Petitions for Adoption of a Foreign-Born Child, and is nearly identical to former Rule 15.9.

- 15.16 a new Rule that provides for notice (which is essentially a notice to plead) to be given when a party files to modify, enforce, or discontinue a Contact Agreement, specifies who the notice must be given to, and requires the filing of a certificate of service.
- 15.17 a new Rule that details the information that must be included in a Petition to Modify Contact Agreement.
- 15.18 a new Rule that details the information that must be included in a Petition to Enforce Contact Agreement.
- 15.19 a new Rule that details the information that must be included in Petitions to Discontinue Contact Agreement.
  - 15.20 a new Rule that discusses maintenance of the court file by the Clerk.
- 15.21 provides that all court records and documents in the court file shall be private and generally withheld from inspection. This Rule is based on former Rule 15.7 but was revised in lights of amendments to the Adoption Act and the Court's Public Access Policy that became effective on Jan. 1, 2018.
- 15.22 a new Rule that provides the process by which someone may request the release of both identifying and non-identifying information about other parties in an adoption process.

# CRIMINAL CASES

Wayne County District Attorney A.G. Howell announced the following cases were addressed by the Honorable Janine Edwards, President Judge Wayne County Court:

# HONESDALE, PA- June 30, 2022

TIFFANY ANNE BROWNELL, age 34 of Moscow Pa, previously sentenced on December 3, 2020 to 18 months probation related to a Burglary, was resentenced to undergo incarceration in the Wayne County Correctional Facility for a period of not less than 2 days nor more than 23 ½ months. She was also ordered to pay restitution of \$2,198.20, undergo a drug and alcohol evaluation and comply with any recommendations for treatment, obtain employment within 60 days of parole or provide documentation from a doctor precluding her from employment. The Defendant was found in violation of her probation when she failed to make the required payments towards the restitution.

NELSON ARTHUR COREY, age 71 of Waymart Pa, was sentenced to undergo incarceration in a State Correctional Institution for a period of not less than 21 months nor more than 120 months plus a mandatory 3 years probation for one count of Possession of Child Pornography-Second Offense (F2). He was also ordered to pay the costs of prosecution, and is subject to a 15 year registration period as a Tier I offender. The incident occurred between July 16, 2021 and August 11, 2021 in Clinton Township, when PSP Troopers conducted undercover investigations into the internet sharing of child pornography. They received a report concerning the possession of child pornography on the eDonkey file sharing network using client software which was reported as eMule. On this same date, the Defendant used the Person 2 person to successfully downloaded and saved a file which was previously known through investigations to be child pornography. On 08/11/21 at approximately 0615 am, law enforcement executed a search warrant at the Defendant's residence. Nearly 500 images images and videos of files depicting child pornography were discovered on the Defendant's computer

MELISSA DELIA FINCH, age 35 of Childs Pa, previously sentenced on February 10, 2022 to 72 hours to 6 months in the Wayne County Correction Facility related to a Driving Under the of Alcohol, was remanded to the Wayne County Correctional Facility for the remainder of her sentence, which is August 7, 2022. The Defendant was found in violation of her probation when she failed to report to her scheduled appointments and failed to make restitution payments as required.

BENEDICT KUPLACK, age 18 of San Antonio TX, was sentenced to undergo incarceration in the Wayne County Correctional Facility for a period of not less than 1 month nor more than 60 months for one court of Indecent Assault (M1). He was also ordered to pay the costs of prosecution, pay restitution not to exceed \$10,000.00, have not contact with the victim, have no unsupervised contact with any child under the age of 18 unless approved by parole, undergo a sex offender evaluation within 30 days of parole and

comply with all treatment recommendations, undergo a drug and alcohol evaluation and comply with any recommendations for treatment, continue with mental health treatment and comply with any recommendations for treatment, obtain employment within 60 days of parole or provide documentation from a doctor precluding him from employment, relinquish any firearm and ammunition to law enforcement within 24 hours, and is subject to a Lifetime registration period as a Tier III offender. The incident occurred on November 28, 2021 in South Canaan Township.

ANTHONY PASCAVAGE, age 31 of Hawley Pa, previously sentenced on March 10, 2022 to 6 months probation related to Sale or Transfer of Firearms-Makes Materially False Written Statements, was resentenced to undergo incarceration in the Wayne County Correctional Facility for a period of not less than 5 days nor more than 12 months with 3 months house arrest through the SCRAM program. He was also ordered to pay the costs of prosecution, undergo a drug and alcohol evaluation and comply with all treatment recommendations, maintain or obtain employment within 30 days of parole or provide documentation from a doctor precluding him from employment. The Defendant was found in violation when he tested positive for alcohol.

ROY WADE TIGUE, age 47 of Hawley Pa, was sentenced to undergo incarceration in a State Correctional Institute for a period of not less than 26 months nor more than 102 months for one count Theft by Unlawful Taking (M1), one count Defiant Trespass (M3), one count Driving While Operating Privileges Suspended/Revoked (S), one count DUI (M), two counts Receiving Stolen Property (M2), and Resisting Arrest (M2). He as also ordered to pay the costs of prosecution, pay a mandatory fine of \$1,200.00, participate in and cooperate with the drug and alcohol addiction treatment in accordance with his assessment, and complete the Alcohol Highway Safety Course. The incidents occurred on April 4, 2019 in Paupack Township, October 12, 2020 in Texas Township, July 15, 2021 in Salem Township, and July 20, 2021 in Paupack Township.

CHARLES STEWART WARNOTT, age 39 of Honesdale Pa, was placed probation for a period of 18 months for one count Possession of Controlled Substance – Heroin (M), one count Possession of Drug Paraphernalia (M), and one count Aiding Consummation of Crime (M2). He was also ordered to pay the costs of prosecution, pay a fine of \$500.00 and undergo a drug and alcohol evaluation and comply with any recommendations for treatment. The incidents occurred between August 1, 2018 and January 11, 2019 in various locations throughout Pike and Wayne Counties.

MARK A. YANTORN, age 37 of Scranton Pa, previously sentenced on February 17, 2022 to one month to 6 months in the Wayne County Correctional Facility related to Driving Under the Influence, was remanded to the Wayne County Correctional Facility for 126 days of the unserved portion of his sentence. The Defendant was found in violation of his parole with he failed to report to schedule appointments and failed to make contact with his parole officer.

KIMBERLY HOWARD, age 52 of Rochester NY, was issued a Bench Warrant for failure to appear at court.




