### CRIMINAL CASES

Wayne County District Attorney A.G. Howell announced the following case was addressed by the Honorable Janine Edwards, President Judge Wayne County Court:

### HONESDALE, PA-June 29, 2022

KEVIN MONAGHAN BRADFORD, age 47 of New Orleans LA, pas placed on the Accelerated Rehabilitation Disposition Program for a period of 6 months related to Sale or Transfer of Firearms-Makes Materially False Statement. He was also ordered to pay all costs, and undergo a drug and alcohol evaluation and comply with all recommendations. The incident occurred on September 10, 2021 in Honesdale Borough.

ALAURA LYNN DELONG, age 23 OF Neversink NY, was sentenced to undergo incarceration in the Wayne County Correctional Facility for a period of not less than 17 days nor more than 6 months for one count of Possession of Controlled Substance (M) and one count Possession of Drug Paraphernalia (M). She was also ordered to pay the costs of prosecution, pay a fine of \$100.00, and undergo a drug and alcohol evaluation and comply with any recommendations for treatment. The incident occurred on October 21, 2020 in Paupack Township.

AMY CHRISTINE GROW, age 38 of Macungie Pa, was sentenced to undergo incarceration in the Wayne County Correctional Facility for a period of not less than 3 days nor more than 12 months for one count Retail Theft – Take Merchandise (F3). She was also ordered to pay the costs of prosecution, pay restitution in the amount of \$130.39, continue with mental health treatment and comply with any recommendations for treatment, and maintain employment or provide documentation from a doctor precluding her from employment. He was also ordered to pay the costs of prosecution, pay a fine of \$700.00, participate in and cooperate with the drug and alcohol addiction treatment in accordance with his assessment, and complete the Alcohol Highway Safety Program. The incident occurred on November 10, 2021 in Lehigh Township.


