#### June 20, 2022 – Driver of Drugs Arrested

The Wayne County District Attorney announced the arrest of Tupico Lynn Jefferson, age 50, of Honesdale Borough for Conspiracy to Possess with Intent to Deliver Cocaine. A true and correct copy of the complaint is enclosed with this press release.

The Complaint alleges the Defendant drove Joseph Castellano in Castellano's car to Stroudsburg to purchase cocaine in exchange for marijuana.

Joseph Castellano also has drug charges pending in Wayne County.

The Central Court date is set for July 27, 2022. District Magistrate Judge Kay Bates set bail at \$100,000.00. The Defendant is held in the Wayne County Correctional Facility.

\*The filing of criminal charges is not evidence of guilt but simply a description of the charge made by the Commonwealth against a defendant. A charged Defendant is presumed innocent until a jury returns a unanimous finding that the Commonwealth has proven the defendant's guilt beyond a reasonable doubt or until the defendant enters a guilty plea to the charges.

#### July 20, 2022 - Arrest for Sexual Assault of minor child

The Wayne County District Attorney announced the arrest of Jeremy Daniel Briscese, age 40, of Waymart PA, for sexually assaulting a minor child. The Defendant is charged with 143 counts each related to Rape, Rape of a Child, Involuntary Deviate Sexual Intercourse, Statutory Sexual Assault, Sexual Assault, Aggravated Indecent Assault, Indecent Assault, Endangering the Welfare of a Minor Child, Corruption of Minors, Unlawful Contact of a Minor Child, Criminal Use of a Communication Facility, Intimidation of a Witness/Victim, and other related charges. A true and correct copy of the complaint is enclosed with this press release. Certain charges and information have been redacted from the Complaint to protect the identity of the minor victim.

The Complaint alleges the Defendant had sexual intercourse with a minor from about March 2021 to February 2022. The Complaint alleges the Defendant kept a record of the sexual assaults by marking his calendar with hearts, totaling 143 hearts. The Central Court date is set for July 27, 2022. District Magistrate Judge Kay Bates set bail at \$500,000.00. The Defendant is held in the Wayne County Correctional Facility. \*The filing of criminal charges is not evidence of guilt but simply a description of the charge made by the Commonwealth against a defendant. A charged Defendant is presumed innocent until a jury returns a unanimous finding that the Commonwealth has proven the defendant's guilt beyond a reasonable doubt or until the defendant enters a guilty plea to the charges.

The Defendants, Kwun Kin Ng and Wun Ching Ng, his Wife in Trust for Dixon, Kelly and Minnie Ng purchased the property described as located in the Township of Paupack, County of Wayne, State of Pennsylvania and specifically Lot Number 35 Section 4 as shown on Plan of Lots Wallenpaupack Lake Estates dated March 3, 1971 with this said purchase recorded in Deed Book Volume 327 at Page 803.

The Defendants, Kwun Kin Ng and Wun Ching Ng, his Wife who held said property in Trust for Dixon, Kelly and Minnie Ng lost the property at a Tax Sale on November 12, 2002, Said Deed was recorded in Deed Book Volume 206 at Page 242.
