#### CRIMINAL CASES

Wayne County District Attorney A.G. Howell announced the following cases were addressed by the Honorable Janine Edwards, President Judge Wayne County Court:

#### HONESDALE, PA- September 1, 2022

KATIE LYNN BOZELLA, age 29 of Honesdale PA, was sentenced to 12 months of probation with restrictive conditions to include House Arrest for a period of 1 month through the SCRAM program for one count Possession Small Amount- Marijuana (M) and one count Possession of Drug Paraphernalia (M). She was also ordered to undergo a drug and alcohol evaluation and comply with any recommendations for treatment, undergo a mental health evaluation, obtain employment within 60 days of parole or provide documentation from a doctor precluding her from employment.

CHRISTOPHER CLARK, age 50 of Gouldsboro PA, was sentenced to undergo incarceration in the Wayne County Correctional Facility for a period of not less than 11 months nor more than 23 ½ months for one count of Simple Assault (M2). He was also ordered to undergo a drug and alcohol evaluation and comply with any recommendations for treatment, undergo a mental health evaluation and comply with any recommendations for treatment, and attend an anger management course. The incident occurred January 23, 2022 in Lehigh Township.

AUTUMN NICOLE DELONG- VANDERHOFF, age 36 of Honesdale PA, was sentenced to probation for a period of 12 months for one count of Retail Theft- Under Ring Sales (M2). She was also ordered to continue with mental health treatment, maintain employment or provide documentation from a doctor precluding her from employment, and pay the costs of prosecution. This incident occurred on December 18, 2021 in Texas Township.

TAMARA ANN FLETCHER, age 51 of Honesdale PA, was sentenced to undergo incarceration in the Wayne County Correctional Facility for a period of not less than 6 month nor more than 23 ½ months followed by probation with restrictive conditions to include House Arrest through the SCRAM Program for 3 months for one count of Retail Theft (F3) and one count of Buying/Exchanging SNAP Benefits (M1). She was also ordered to pay the costs of prosecution, pay restitution of \$32.58, continue with drug and alcohol treatment, and continue with mental health treatment and comply with any recommendations for treatment. These incidents occurred on December 21, 2020 and February 26, 2021 in Texas Township

BRIDGET LYNN GILLIGAN, age 28 of Honesdale PA, was sentenced to 12 months of probation for one count of Unlawful Taking or Disposition (M3). She was also ordered pay restitution in the amount of \$245.00, undergo a drug and alcohol evaluation and comply with any recommendations for treatment, and maintain or obtain employment within 30 days of sentencing or provide documentation from a doctor precluding her from employment. This incident occurred on December 25, 2021 in Honesdale Borough.

FREDERICK J. HENDERSHOT, age 63 of Hawley PA, previously sentenced on February 10, 2022 to one month to 6 months of probation related to Driving Under the Influence, was remanded to the Wayne County Correctional Facility for not less than 2 days nor more than 6 months of the unserved portion of his sentence. The Defendant was found in violation of his parole with he failed to participate in Recovery Support Services with Wayne County Drug and Alcohol.

LOUIS BENJAMIN HOLLISTER, age 51 of Hawley Pa, was sentenced to 6 months of probation with one month of House Arrest through the SCRAM Program for one count DUI-Alcohol/Controlled Substance (M). He was also ordered to pay the costs of prosecution, pay a mandatory fine of \$1,000.00, undergo a mental health evaluation, participate in and cooperate with the drug and alcohol addiction treatment in accordance with his assessment, and complete the Alcohol Highway Safety Course. The incident occurred on November 21, 2021 in Palmyra Township.

FREDERICK C. STREIN, age 50 of Moosic PA, was placed on probation for a period of 6 months for one count False Swearing (M3). He was also ordered to pay the costs of prosecution, pay a fine of \$300.00 and maintain employment or provide documentation from a doctor precluding him from employment.

DOTTIE WEST, age 46 of Pleasant Mount PA, was sentenced to pay a \$300 fine, pay the costs of prosecution, and complete 20 hours of Community Service for one count of Confinement and Control-Firmly Secured by Collar or Chain (M3). The incident occurred on February 28, 2022 in Mount Pleasant Township.

TODD WIGNALL, age 55 of Gouldsboro PA, previously sentenced on June 2, 2022 to 6 months to 12 months in the Wayne County Correctional Facility less credit time, was remanded back to the Wayne County Correctional Facility for the remainder of his sentence. The Defendant was found in violation of his parole on August 17, 2022 when he failed a drug test.

CHRISTOPHER GEORGE JONES, age 54 of Hawley PA, was issued a Bench Warrant for failure to appear
