MONROE COUNTY MAN CHARGED WITH DRUG DELIVERY

December 5, 2022 — Wayne County District Attorney A.G. Howell today announced that Myles A. Davis, age 34, has been charged with selling the drugs.

On November 2, 2022, Davis sold cocaine to a confidential informant. On December 1, 2022, Davis was pulled over by state troopers for traffic violations and subsequently arrested by State Police.

Davis is currently on parole for a federal conviction of drug trafficking.

*The filing of criminal charges is not evidence of guilt but simply a description of the charge made by the Commonwealth against a defendant. A charged Defendant is presumed innocent until a jury returns a unanimous finding that the Commonwealth has proven the defendant's guilt beyond a reasonable doubt or until the defendant enters a guilty plea to the charges.
