# PRESS RELEASE

*December 21, 2022* — Wayne County District Attorney A.G. Howell announced the arrest of Christopher Mauricio, III, age 20, for scheming \$9,000.00 away from the victim. The Defendant is charged with Theft by Deception (F3), Receiving Stolen Property (F3), and Criminal Use of a Communication Facility (F3). A copy of the Criminal Complaint with the full details is enclosed with this press release.

The Complaint alleges the Defendant was involved in a scheme to steal money from the victim. The Defendant and others took part in a scheme pretending to be the victim's son who was supposedly charged with crimes in another and needed bail money. The imposter lied about being her son and in trouble. The victim provided \$9,000.00 cash in the belief she was helping her son. Thankfully, the victim's son was okay and not in trouble.

# PRESS RELEASE

*December 21, 2022* — Wayne County District Attorney A.G. Howell announced the arrest of Gerald Howard Sheerer of Waymart PA for sexually assaulting a minor. Sheerer is charged with Indecent Assault Person Less Than 13 Years Age, Indecent Assault Person Less Than 16 Years Age, Involuntary Deviate Sexual Intercourse with Child, Involuntary Deviate Sexual Intercourse Person Less than 16 Years age. A copy of the Criminal Complaint is enclosed with this press release. Certain information has been redacted from the Complaint to protect the identity of the victim.

The Complaint alleges the Defendant had sexual relations with the minor victim over the course of 6 years and began when the victim was approximately 9 years of age and ended when the victim was approximately 14 years of age.

On December 29, 2021, Mr. Sheerer was charged with aggravated indecent assault and indecent assault for inappropriate with another minor child. These charges are still pending. A copy of this Criminal Complaint is also enclosed with this press release. Certain information has been redacted from the Complaint to protect the identity of the victim.


