District Attorney's Office — Press Release

MAN SENTENCED TO 20 MONTHS - 60 MONTHS FOR STABBING

January 9, 2023 — Wayne County District Attorney A.G. Howell, announced today that Joseph Costabile, age 38, of Greentown PA, was sentenced by Wayne County President Judge Janine Edwards to not less than 20 months nor more than 60 months for stabbing the victim, Christopher Nagel. Mr. Costabile previously pled guilty to Aggravated Assault with a deadly weapon (F2).

He is also awaiting sentencing in Staten Island New York after he allegedly a man in the leg outside the man's and then fled the scene on May 19,2021.

In the early morning hours of July 11, 2020, the Defendant, Daniel Motz, and the victim got into an altercation after the Defendant threw fireworks at bystanders outside Cordaro's restaurant as the Defendant drove away. During the altercation, the Defendant stabbed the victim in his abdomen and thigh.

CRIMINAL CASES

Wayne County District Attorney A.G. Howell announced the following cases were addressed by the Honorable Janine Edwards, President Judge Wayne County Court:

HONESDALE, PA — December 29, 2022

ANDREW BELLINO, age 30 of Honesdale PA, was sentenced to the Intermediate Punishment Program for a period of 2 years, to include 90 days of house arrest through the SCRAM program, for one count of Simple Assault (M2). He was also ordered to pay the costs of prosecution, undergo a mental health evaluation, and maintain employment while on probation or provide documentation from a doctor precluding him from employment. The incident occurred July 25, 2022 in Honesdale Borough.

MICHAEL LOTURCO, age 60 of Orangeburg NY, was sentenced to 6 months probation for one count DUI (M). He was also ordered to pay the costs of prosecution, pay a \$300.00 fine, participate in and cooperate with the drug and alcohol addiction treatment in accordance with his assessment, and complete the Alcohol Highway Safety Program. The incident occurred on June 2, 2021 in Sterling Township.

JACOB CORBIN SCHUMACHER, age 24 of Honesdale PA, was sentenced to not less than 9 days nor more than 23 ½ months incarceration in the Wayne County Correctional Facility for one count Forgery (F3). He was also ordered to pay the costs of prosecution, pay restitution in the amount of \$2,284.45, undergo a mental health evaluation, and continue services with the Wayne County Drug and Alcohol Commission's Recovery Support. The incidents occurred between January 18, 2022 and February 22, 2022 in Cherry Ridge Township.

LAWRENCE W. MULLALLY, age 67 of Beach Lake PA, was sentenced to 6 months probation for one count Possession of Drug Paraphernalia (M). He was also ordered to pay the costs of prosecution and pay a \$500.00 fine. The incident occurred August 16, 2022 in Damascus Township.

LEROY JOHN CARD, age 45 of Hancock NY, was sentenced to incarceration in a State Correctional for a period of not lea than 14 months nor more than 48 months, for one count of Corruption of minors- Related to Sexual Offenses (F3). He was also ordered to pay the costs of prosecution, pay restitution to The Victim Compensation Assistance Program, and register as a Tier II offender subject to a 25 year registration period.
