CHILD ENDANGERMENT BROUGHT AGAINST LAKE ARIEL MAN

November 28, 2023 — Wayne County District Attorney A.G. Howell



ARMANDO CAPO

announced child endangerment and resisting charges filed against Armando Capo, 50, of Lake Ariel PA.

In the complaint and affidavit of probable cause, it is alleged Capo lived in a dilapidated camper along with his 15 year old child who is nonverbal autistic. The ramshackle camper had minimal electric, no water, no food, and was not clean. His next court appearance will be Wednesday, December 6, 2023, at central court in the Wayne County Courthouse. Capo posted bail through a bail bondsman.

The filing of criminal charges is not evidence of guilt but simply a description of the charge made by the Commonwealth against a defendant. A charged Defendant is presumed innocent until a jury returns a unanimous finding that the Commonwealth has proven the defendant's guilt beyond a reasonable doubt or until the defendant enters a guilty plea to the charges.
