#### WAYNE COUNTY MAN ARRESTED FOR CHILD PORNOGRAPHY

December 27, 2023 — Wayne County District Attorney A.G. Howell announced today the arrest of Christopher Foster, age 29, of Salem Township, Wayne County, PA. He was arrested and charged with 500 counts of Child Pornography, graded as a felony 2nd degree, 500 counts of Child Pornography, graded as a felony 3rd degree, one count of Dissemination of Child Pornography, a felony 3rd degree, one count of Dissemination of Photographs, Videotapes, Computer Depictions and Films, a felony 3rd degree, two counts of Photographing, Videotaping, Depicting on Computer or Filming Sexual Acts, a felony 2nd degree, two counts of Corruption of Minors, a misdemeanor 1st degree, two counts of Unlawful Contact with Minor, a felony 2nd degree and two counts of Criminal Use of Communication Facility, a felony 3rd degree.

The arrest stemmed from an investigation that started in Chatham County, North Carolina when a 13-year-old male reported to his mother that he had been in contact with an adult male while playing Xbox online. The adult male had convinced that juvenile and another juvenile to send him sexually explicit videos and photographs. The adult male and the juveniles also used "Discord" and "Snapchat" to send and received explicit videos and photographs of each other. The adult male also sent the juveniles money for the videos and photographs.

Investigators in North Carolina were able to identify the adult male as Christopher Foster from Moscow, PA. Initially, the Lackawanna County Detectives were contacted. However, once it was determined that Foster lived in Wayne County, the Wayne County Detective became involved along with the PA State Police Northeast Computer Crimes Unit.

A search warrant was served at Foster's residence today by members of the PA Internet Crimes Against Children (ICAC) Task Force, which the Wayne County Detectives are a part of. During the search, approximately 165,000 files depicting child pornography were found on Foster's electronic devices. Foster was arrested and brought before Magisterial District Judge Carney for a preliminary arraignment. Bail was set at \$200,000.00 secure and he was remanded to the Wayne County Correctional Facility. His next court appearance is scheduled for January 3, 2024 at 9:00 am at the Wayne County Courthouse.

<sup>\*</sup>The filing of criminal charges is not evidence of guilt but simply a description of the charge made by the Commonwealth against a defendant. A charged Defendant is presumed innocent until a jury returns a unanimous finding that the Commonwealth has proven the defendant's guilt beyond a reasonable doubt or until the defendant enters a guilty plea to the charges.
