## INMATE CHARGED WITH ASSAULTING A CORRECTIONS OFFICER

September 8, 2025 — Wayne County District Attorney A.G. Howell announced today the arrest of Holly Elizabeth Miceli, age 45, of Greentown, Pike County, Pennsylvania. Miceli was arrested and charged with one count of assault by prisoner, a felony of the 2nd degree, one count of simple assault, a misdemeanor of the 2nd degree, two counts of disorderly conduct, a misdemeanor of the 3rd degree and one count of harassment, a summary.

According to the criminal complaint and affidavit of probable cause filed by Wayne County Detective Michael McMorrow, On August 30, 2025, a Wayne County Corrections Officer was assaulted following an altercation with an

inmate who refused to shower since entering the facility.

The inmate, identified as Holly Miceli, approached the Wayne County Corrections Officer from behind and struck the officer in the head with a closed fist causing bodily injury. Additionally, the officer sustained injuries to their arm.

District Attorney A.G. Howell stated the Officer has since recovered from their injuries and returned to full duty. Wayne County is home to three correctional institutions and anyone who

assaults any prison guard in Wayne County will be held accountable through new criminal charges and internal disciplinary measures.

A preliminary arraignment was conducted by Magisterial District Judge Bonnie L. Carney and Miceli was remanded back to the Wayne County Correctional Facility on \$100,000.00 secured bail. Miceli is due in Central Court on September 10, 2025 at 9:00 am.

<sup>\*</sup>The filing of criminal charges is not evidence of guilt but simply a description of the charge made by the Commonwealth against a defendant. A charged Defendant is presumed innocent until a jury returns a unanimous finding that the Commonwealth has proven the defendant's guilt beyond a reasonable doubt or until the defendant enters a guilty plea to the charges.
