Editorial (according to the criminal complaint):

On 07/26/25 at approximately 0900hrs, the defendant entered Mike's Towing in Palmyra Township without permission. He bypassed the gate, entered an enclosed area, and accessed a vehicle that was part of an active hit-and-run police investigation. Items, including tools, were removed from the vehicle before he left.

The owner reported the trespass, and video surveillance confirmed the defendant's actions. In a later interview, the defendant admitted to going to the lot and taking the property. He claimed he believed the items belonged to the vehicle owner's girlfriend, but she later stated she never gave him permission. She also reported that he was persistent about retrieving the items because he knew there was drug-related paraphernalia inside the vehicle.

Store personnel identified the defendant in the entry area and confirmed his involvement in the theft. Further review revealed that the incident was part of a broader pattern of conduct involving merchandise and monetary losses at the same location spanning multiple dates.

Witnesses stated that the male stood up and walked around the pool area before being asked to leave.

Resort staff confirmed that the male, who was not a registered guest, had been in the pool area unclothed alongside an unidentified female. After getting dressed, the two were escorted from the resort. Staff described their vehicle as a gray Volkswagen Passat with New York registration.

The defendant was later identified and contacted by phone, where he denied knowledge of the incident but suggested there may have been a wardrobe malfunction. Based on the report, a summons was requested.

The Wayne County District Attorney's Office received a fraud complaint involving the defendant. The complainant reported being shown diamonds and documents to support a business deal, with promises of resale profits in New York.

The complainant wired \$45,000 to the defendant's bank account. The defendant later allegedly traveled to Africa, claiming authorities had confiscated the money and diamonds, and further claimed he lost \$129,000 of his own funds.

Bank records confirmed the \$45,000 transfer and subsequent withdrawals totaling the same amount.

A needle cap was found in his pocket, and he later admitted the uncapped needle was in his pants. A search of the truck uncovered about 50 bags of fentanyl stamped "Call of Duty." Blood tests confirmed narcotics in his system.

Records showed multiple Keeno ticket sales and vouchers cashed at different locations, with the total amount stolen calculated at \$25,324. Witnesses confirmed the defendant had direct access to the lottery machines and scratch-off dispenser, and surveillance placed him at terminals during transactions.

When questioned, the defendant admitted to past misconduct, acknowledged owing money, and sent messages indicating he would try to repay losses.

Upon arrival, officers spoke with the victim who stated that the defendant had been banging on the door after 2300hrs, demanding to be let inside. When entry was refused, the defendant forced his way in and placed the victim in a chokehold, causing them to lose consciousness.

A witness reported observing the defendant holding the victim in the chokehold and yelling, refusing to release until threatened with police notification. The victim sustained visible injuries and later sought medical treatment. The defendant was reported to be intoxicated at the time and is currently on probation.
