Editorial (according to the criminal complaint):

On August 26, 2025, the defendant was found inside a crashed Cadillac SRX on the Cochecton Turnpike in Damascus Township. Troopers reported the defendant was asleep behind the wheel with the keys in the ignition and a strong odor of alcohol present. After being woken, the defendant admitted to drinking earlier and showed signs of impairment. A blood test later confirmed a BAC of .18, more than twice the legal limit.

^{*}The filing of criminal charges is not evidence of guilt but simply a description of the charge made by the Commonwealth against a defendant. A charged Defendant is presumed innocent until a jury returns a unanimous finding that the Commonwealth has proven the defendant's guilt beyond a reasonable doubt or until the defendant enters a guilty plea to the charges.*
