#### MAN SENTENCED FOR KILLING BELOVED POSTMASTER OF WHITE MILLS

October 16, 2025 — On October 16, 2025, Tyler Canfield, age 28, of Honesdale, PA, was sentenced to 70 months to 140 months in a State Correctional Facility for killing Elizabeth Struble while operating a motor vehicle while under the influence of alcohol.

The incident occurred on October 5, 2024, around 2:33 p.m., when the defendant was driving west on Route 6 in Palmyra Township, just west of Hawleywood Hills. The defendant crossed the center line of Route 6, striking an oncoming vehicle and causing the other driver to die at the scene. A witness reported seeing the defendant cross the center line multiple times, swerve toward the left, nearly hit the Hawleywood Hills sign and rock wall, and then swerve back into his lane.

When officers arrived and began attending to the victims, the defendant crawled over the guardrail after being instructed to remain at the scene for medical evaluation. Officers noticed a strong odor of alcohol on the defendant's breath, as well as unsteady balance, bloodshot eyes, and slurred, slow speech. Although initially agreed to wait, the defendant fled the scene but was quickly apprehended. He was identified as Tyler Canfield.

The defendant was transported to the hospital for a blood test, which he first refused but later consented to. His blood alcohol content (BAC) was measured at 0.30.
