On December 7, 2025, the victim/recipient of an email reported to PSP of receiving an email with an address identifying another victim, Korin Avery Carl. The email contained three caricatures, two of which were antisemitic and one depicting a swastika. The email also included explicit antisemitic language that placed the victims in fear for their safety.

In the afternoon of December 15, 2025, John A. Maddi came forward to PSP admitting to framing Ms. Carl by creating a fake and forged email account to send the intimidating email on December 7, 2025. Enclosed is the Complaint and Affidavit with further information regarding the charges filed against Mr. Maddi.

In the morning, on December 16, 2025, the District Attorney's Office withdrew charges initially filed against one of the victims, Korin Carl.

The filing of criminal charges is not evidence of guilt but simply a description of the charge made by the Commonwealth against a defendant. A charged Defendant is presumed innocent until a jury returns a unanimous finding that the Commonwealth has proven the defendant's guilt beyond a reasonable doubt or until the defendant enters a guilty plea to the charges.
